SCHEDULE 4 (cont.)

(2) A subscriber shall not, without the written consent of the Post Office :

(a) alter or remove an installation or any part thereof, or obliterate or deface any marks thereon;

(b) place or use in any manner or position in relation to an installation any thing that may have a harmful effect on the installation or on the use of the installation for the purposes for which it was provided or on the quality of the telex service; or

(c) permit or suffer any other person except an officer of the Post Office so to do.

(3) The subscriber shall, on being required by the Post Office so to do, forthwith cease to use and remove any thing which has been attached, connected, placed or used as mentioned in sub-paragraphs (1) and (2) whether by the subscriber or by another person and whether or not consent has been given as aforesaid, and any thing which has been placed in such manner or position in relation to an installation that in the opinion of the Post Office its use has had or may have a harmful effect on the installation or on the use of the installation for the purposes for which it was provided or on the quality of the telex service."

SCHEME T5/1972

NOTE: The Scheme which follows this Note has been made under section 28 of the Post Office Act 1969 and will come into operation on 1st January 1973. It amends the Post Office Inland Telegram Scheme 1971 (Post Office Scheme T3/1971) so that the provisions which prescribe the charges and conditions for inland telegrams no longer apply to telegrams sent from the Channel Islands, consequent upon the agreement between the Post Office and the Channel Islands Authorities for the surrender of the Post Office telecommunications monopoly within the Channel Islands in favour of the Authorities.

THE POST OFFICE INLAND TELEGRAM AMENDMENT (No. 1) SCHEME 1972

Made - - - - 15th December 1972

Coming into operation 1st January 1973

The Post Office, by virtue of the powers conferred upon it by section 28 of the Post Office Act 1969, and of all other powers enabling it in this behalf, hereby makes the following Scheme:

Commencement and Citation

1. This Scheme shall come into operation on the 1st day of January 1973 and may be cited as the Post Office Inland Telegram Amendment (No. 1) Scheme 1972.

Interpretation

2.—(1) This Scheme shall be read as one with the Post Office Inland Telegram Scheme 1971 (Post Office Scheme T3/1971) (hereinafter called "the principal Scheme").

(2) The Interpretation Act 1889 applies for the interpretation of this Scheme as it applies for the interpretation of an Act of Parliament.

Application

4. In paragraph 4 of the principal Scheme, the words "United Kingdom or the Isle of Man" shall be substituted for the words "British Islands" in the three places where they occur. In the same paragraph, after the words "Republic of Ireland' in both places where they occur, there shall be inserted the words "or the Channel Islands."

Additional charges for certain telegrams

5. In paragraph 7(c) of the principal Scheme the words "any part of the United Kingdom (other than Scotland) or the Isle of Man" shall be substituted for the words "any part of the British Islands other than Scotland."

Money order telegrams

6. In paragraph 8 of the principal Scheme the words "United Kingdom or the Isle of Man" shall be substituted for the words "British Islands" in the first place where they occur. In subparagraph (e) of the same paragraph the words "any part of the United Kingdom (other than Scotland) or the Isle of Man" shall be substituted for the words "any part of the British Islands other than Scotland".

Counting of words

7. In paragraph 10(d) of the principal Scheme the words "United Kingdom or the Isle of Man" shall be substituted for the words "British Islands".

Cancellation by sender

8. In paragraph 19(c) of the principal Scheme the words "any part of the United Kingdom (other than Scotland) or the Isle of Man" shall be substituted for the words "any part of the British Islands other than Scotland".

Application to the Republic of Ireland and the Channel Islands

9. For paragraph 39 of the principal Scheme there shall be inserted the following paragraph:

"APPLICATION TO THE REPUBLIC OF IRELAND AND THE CHANNEL ISLANDS

39. The provisions of this Scheme shall apply to written telegrams between the United Kingdom or the Isle of Man and the Republic of Ireland or the Channel Islands so far as relates to the transmission, delivery and treatment of the telegrams under the authority of the Post Office.

Provided that:

(a) For telegrams to the Republic of Ireland

(i) there shall be charged and paid for the transmission of every telegram to a place in the Republic of Ireland, if the length of the telegram does not exceed twelve words, 30p, and, if the length of the telegram exceeds twelve words, 30p for the first twelve words and 2p for each additional word, with the additional charge of $12\frac{1}{2}p$ if the telegram is tendered on a Sunday, or is tendered on Christmas Day or Good Friday in any part of the United Kingdom or the Isle of Man other than Scotland;

(ii) telegrams will not be accepted for transmission to the Republic of Ireland as greetings telegrams, overnight telegrams, or priority telegrams;

(iii) the charges for the delivery of telegrams by special messenger beyond the limit of free delivery in the Republic of Ireland shall not be prepaid by the sender ;

(iv) in the case of a money order telegram applied for at a Money Order Office in the United Kingdom or the Isle of Man and payable in the Republic of Ireland, paragraph 8 (except sub-paragraphs (c) and (d) thereof) shall apply with the substitution of the sum of 30p for the sum of 25p as the minimum charge payable in respect of the service telegram authorising payment;

(v) paragraph 15 shall apply with the substitution of such sums as the Post Office may fix for the minimum and maximum sums specified in that paragraph."
