THE POST OFFICE OVERSEAS LETTER POST AMENDMENT (No. 7) SCHEME 1974

Made 23rd May 1974

Coming into operation 24th June 1974

The Post Office by virtue of the powers conferred upon it by Section 28 of the Post Office Act 1969, and of all other powers enabling it in this behalf, hereby makes the following Scheme:

Commencement, citation and interpretation

- 1.—(1) This Scheme shall come into operation on the 24th day of June 1974 and may be cited as the Post Office Overseas Letter Post Amendment (No. 7) Scheme 1974.
- (2) This Scheme shall be read as one with the Post Office Overseas Letter Post Scheme 1971 (Post Office Scheme P7/1971) hereinafter called "the Scheme") as amended by the Post Office Overseas Letter Post Amendment (No. 1) Scheme 1972 Post Office Scheme P2/1972), the Post Office Overseas Letter Post Amendment (No. 2) Scheme 1972 (Post Office Scheme P6/1972), the Post Office Overseas Letter Post Amendment No. 3) Scheme 1972 (Post Office Scheme P8/1972) the Post Office Overseas Letter Post Amendment (No. 4) Scheme 1973 (Post Office Scheme P2/1973), The Post Office Overseas Letter Post Amendment (No. 5) Scheme 1973 (Post Office Scheme P6/1973), and the Post Office Overseas Letter Post Amendment (No. 6) Scheme 1974 (Post Office Scheme P1/1974).
- (3) The Interpretation Act 1889 applies for the interpretation of this Scheme as it applies for the interpretation of an Act of Parliament.

Bulk posting in mail bags

- 2.—(1) In paragraph 11(1)(a) of the Scheme the fee of 12p shall be deleted and 16p inserted in its place and the words "with a minimum charge of £3.68 and a maximum charge of £4.80 for any bag" shall be inserted immediately after the word "contents".
- (2) In paragraph 11(1)(b) of the Scheme the fee of 20p shall be deleted and 23p inserted in its place and the words "with a minimum charge of £5.29 and a maximum charge of £6.90 for any bag" shall be inserted immediately after word "contents"

Articles liable to duty

- 3.—(1) In paragraph 16(3)(a) of the Scheme the fee of 20p shall be deleted and 27p inserted in its place.
- (2) In paragraph 16(3)(b) of the Scheme the fee of 40p shall be deleted and 45p inserted in its place.

Express delivery

4. In paragraph 29 of the Scheme the fee of 20p shall be deleted and 40p inserted in its place.

Registration

5. In paragraph 32(2)(c) of the Scheme the fee of 20p shall be deleted and 25p inserted in its place.

Advice of delivery and enquiries

- ^{6,-(1)} In paragraph 39(1) of the Scheme, for the fees of ^{7½p} and 10p there shall be substituted 10p and 20p respectively.
- (2) In paragraph 39(3) of the Scheme the fee of 10p shall be deleted and 20p inserted in its place.
