The Post Office by virtue of the powers conferred upon it by Section 28 of the Post Office Act 1969, and of all other powers enabling it in this behalf, hereby makes the following Scheme:

## Commencement, citation and interpretation

1.-(1) This Scheme shall come into operation on the 8th July 1974 and may be cited as the Post Office Overseas Letter Post Amendment (No. 7A) Scheme 1974.
(2) This Scheme shall be read as one with the Post Office Overseas Letter Post Scheme 1971 (Post Office Scheme P7/1971) (hereinafter called "the Scheme") as amended by the Post Office Overseas Letter Post Amendment (No. 1) Scheme 1972 (Post Office Scheme P2/1972), the Post Office Overseas Letter Post Amendment (No. 2) Scheme 1972 (Post Office Scheme P6/1972), the Post Office Overseas Letter Post Amendment (No. 3) Scheme 1972 (Post Office Scheme P8/1972), the Post Office Overseas Letter Post Amendment (No. 4) Scheme 1973 (Post Office Scheme P2/1973), the Post Office Overseas Letter Post Amendment (No. 5) Scheme 1973 (Post Office Scheme P6/1973), and the Post Office Overseas Letter Post Amendment (No. 6) Scheme 1974 (Post Office Scheme P1/1974).
(3) The Interpretation Act 1889 applies for the interpretation of this Scheme as it applies for the interpretation of an Act of Parliament.

Bulk posting in mail bags
2.-(1) In paragraph $11(1)(a)$ of the Scheme the fee of $12 p$ shall be deleted and $16 p$ inserted in its place and the words "with a minimum charge of $£ 3.68$ and a maximum charge of $£ 4.80$ for any bag" shall be inserted immediately after the word "contents".
(2) In paragraph $11(1)(b)$ of the Scheme the fee of 20 p shall be deleted and $23 p$ inserted in its place and the words "with a minimum charge of $£ 5.29$ and a maximum charge of $£ 6.90$ for any bag" shall be inserted immediately after the word "contents".

## Articles liable to duty

3.-(1) In paragraph $16(3)(a)$ of the Scheme the fee of 20 p shall be deleted and 27 p inserted in its place.
(2) In paragraph $16(6)(b)$ of the Scheme the fee of 40 p shall be deleted and $45 p$ inserted in its place.

## Express delivery

4. In paragraph 29 of the Scheme the fee of 20 p shall be deleted and 40 p inserted in its place.

## Registration

5. In paragraph $32(2)(c)$ of the Scheme the fee of 20 p shall be deleted and 25 p inserted in its place.

## Advice of delivery and enquiries

6.-(1) In paragraph $39(1)$ of the Scheme, for the fees of $7 \frac{1}{2} p$ and 10 p there shall be substituted. 10 p and 20 p respectively.
(2) In paragraph $39(3)$ of the Scheme the fee of 10 p shall be deleted, and 20 p inserted in its place.
