Note: The Scheme which follows this Note is made under section 28 of the Post Office Act 1969 and amends the Post Office Overseas Letter Post Scheme 1982. The Scheme, which comes into operation on 3rd September 1984, revises postal charges generally and makes sundry minor alterations to the text.

## THE POST OFFICE OVERSEAS LETTER POST AMENDMENT (NO. 3) SCHEME 1984

The Post Office, by virtue of the powers conferred upon it by section 28 of the Post Office Act 1969, and of all other powers enabling it in this behalf, hereby makes the following Scheme:

## Commencement and citation

1.-(1) This Scheme shall come into operation on 3rd September 1984 and may be cited as the Post Office Overseas Letter Post Amendment (No. 3) Scheme 1984.
(2) This Scheme shall be read as one with the Post Office Overseas Letter Post Scheme 1982 (Post Office Scheme P2/1982) (hereinafter called "the Scheme") as amended by the Post Office Overseas Letter Post Amendment (No. 1) Scheme 1982 (Post Office Scheme P6/1982) and the Post Office Overseas Letter Post Amendment (No. 2) Scheme 1983 (Post Office Scheme P4/1983). Arrangement of paragraphs
2. In Part V of the Arrangement of Paragraphs: (a) the description of paragraph 37, "Compensation-general", shall be deleted and the description "Compensation for certain other postal packets" inserted in its place; (b) the description of paragraph 38, "Advice of delivery and enquiries" shall be deleted and the description "Advice of delivery, enquiries and claims for compensation " inserted in its place.

## Interpretation

3. In sub-paragraph (1) of paragraph 3 of the Scheme as subsequently amended, in the definition of "the Act ", the figures " 1969 " after "British Telecommunications Act" shall be deleted and " 1981 " inserted in their place. Other printed packets and small packets
4. In sub-paragraph (1) of paragraph 7 of the Scheme, the expression " Part 2 " shall be deleted and "Parts 2 and 5 " inserted in its place.
Air mail packets
5. In paragraph $9(b)$ of the Scheme, the amount " $12 \frac{1}{2} \mathrm{p}$ " shall be deleted and " 13 p " inserted in its place.

Bulk posting in mail bags
6.-(1) In sub-paragraph (1)(a) of paragraph 10 of the Scheme as subsequently amended, the amount " 85 p " shall be deleted and " 95 p" inserted in its place.
(2) In sub-paragraph (1)(b) of paragraph 10 of the Scheme as subsequently amended, the amount " $£ 1.05$ " shall be deleted and " $£ 1 \cdot 15$ " inserted in its place.

## Articles liable to duty

7.-(1) In sub-paragraph (3)(a) of paragraph 15 of the Scheme as subsequently amended, " 90 p "shall be deleted and " $£ 1.00$ " inserted in its place.
(2) In sub-paragraph (3)(b) of paragraph 15 of the Scheme as subsequently amended the amount " $£ 1-20$ " shall be deleted and " $£ 1.30$ " inserted in its place.
Payment of postage and fees
8. In sub-paragraph (6) of paragraph 16 of the Scheme, the figures " 1975 " shall be deleted in both places where they occur and " 1979 " inserted in their place.
Unpaid or underpaid postage
9.-(1) In sub-paragraph (4)(a) of paragraph 17 of the Scheme, the amount " 20 p " shall be deleted and " 25 p " inserted in its place.
(2) For sub-paragraph (6) of paragraph 17 of the Scheme, there shall be substituted the following:
"(6) Where the amount chargeable under sub-paragraph (4) or (5) would otherwise be less than $26 p$, the amount charged shall be 26p ".

## Registration

10. In sub-paragraph (2)(c) of paragraph 32 of the Scheme, the amount " $£ 1 \cdot 00$ " shall be deleted and " $£ 1 \cdot 10$ " inserted in its place.
Compensation for registered packets
11.-(1) In sub-paragraph (2)(a) of paragraph 33 of the Scheme, the amount " $£ 500$ " shall be deleted and " $£ 600$ " inserted in its place.
(2) In sub-paragraph (2)(b) of paragraph 33 of the Scheme, the amount " $£ 12$ " shall be deleted and " $£ 13$ " inserted in its place.
Compensation for insured letters
11. In sub-paragraph (10)(b) of paragraph 36 of the Scheme, the reference " $32(1)(d)$ " shall be deleted and the reference " $32(2)(d)$ " inserted in its place.
Compensation for certain other postal packets
12. In sub-paragraph (2) of paragraph 37 of the Scheme, the amount " $£ 12$ " shall be deleted and " $£ 13$ " inserted in its place. International reply coupons
13. In sub-paragraph (2) of paragraph 39 of the Scheme, the amount " 30 p" shall be deleted and " 35 p " inserted in its place. Redirection
15.-(1) In sub-paragraph (2) of paragraph 40 of the Scheme, the figures " 1975 " shall be deleted and " 1979 " inserted in their place.
(2) In sub-paragraph (7) of paragraph 40 of the Scheme, the figures " 1975 " shall be deleted and " 1979 " inserted in their place.
