# THE POST OFFICE OVERSEAS LETTER POST AMENDMENT (NO. 7) SCHEME 1987

Made 23rd February 1987 Coming into operation 30th March 1987

The Post Office, by virtue of the powers conferred upon it by section 28 of the Post Office Act 1969 and of all other powers enabling it in this behalf, hereby makes the following Scheme:

(1) This Scheme shall come into operation on 30th March 1987 and may be cited as the Post Office Letter Post Amendment (No. 7) Scheme 1987.
