INTRODUCTION.....

As is so often the case, when looking for one thing, another - more interesting - comes to light. This time it was a series of books which provide the postal historian with a wealth of information which, as far as can be ascertained, had not been published before. This is the first volume of the two L.P.H.G. propose to make available to members.

Each entry has been given a reference number, known as the "entry number". These entry numbers do not, of course, appear in the original. The page number of the original is shown in the left hand margin immediately above the entry number of the first item from the original page.

Where the one Editor has absentmindedly given the same entry number to more than one entry, the other Editor dealt with it by adding an alpha suffix !

The date of the entry is given first. The dating has been standardised to read DAY, MONTH, with the YEAR entered at the top of each page. Any stamp impressions are placed at the foot of the page with the entry number below the illustration. All stamps were struck in black unless an (R) follows the number, this indicating (R)ed ink was used.

Editorial changes have been made to the original text. At one period it appears the postal clerks were required to sign various notices as having been read. These signatures have been omitted, this being noted by (snr) = signatures not reproduced.

Some copies from the originals are included, either for convenience or to make a point. Tribute must be paid to the Archivist who took what were, clearly, badly damaged books and who managed to recover and preserve what would have otherwise been lost.

The original index is reprinted showing the page references of the original volume. A revised and, hopefully, rather more useful, version has been prepared. This new version may be incomplete but should be sufficient to meet most requirements. In the revised index the entry numbers given, not the page numbers.

Where the original is missing (...) appears but where a reasonable guess as to the word or phrase can be made this is shown in italics and between brackets to distinguish it from original text. Initials and abbreviations are given as they appear. Appendix I offers suggested interpretations for these.

The stamp identifying numbers or letters, from the base of the stamp, are listed with the entry number in Appendix II. As will be seen, the original text used a mixture of "back stamp", "obliterating stamps" and "hand stamps", apparently in an inconsistent manner. All stamp numbers/letters are, therefore, listed consecutively unless identified as "FS", these having their own tabulation.

Metal Date-Stamps showing Clock-Time. Discontinuance of issue of such Stamps of "single" pattern for use in impressing Postal Packets.

Arrangements for custody of Date-Stamps.

Hitherto it has been the practice to issue two patterns of metal date-stamps showing clock-time for use in impressing postal packets, viz., the "combined" date-stamp containing an inner and an outer ring, for obliterating postage stamps, and the "single" date-stamp, having no inner ring, for inward date-stamping. It has now been decided that the "combined" date-stamp, while securing more effective obliteration of postage stamps and affording better protection to the type than the "single" date-stamp, is equally suitable for inward date-stamping and may be used for that purpose. The issue of single metal date-stamps showing clock-time for impressing postal packets will therefore be discontinued, but any such date-stamps now in use should continue in use until they are worn out. No change will be made as regards the issue of date-stamps which do not show clock-time, for use at the counter only.

Attention has been called to a practice which prevails at some Offices of assigning permanently to each Officer engaged on stamping duties a particular date-stamp or set of date-stamps. Experience has shown that at large Offices a considerable saving in the number of date-stamps in use, and in the labour and cost of maintaining them, can be effected if they are placed primarily in the keeping of only two or three Officers, whose attendances should be such that one is always on duty while the date-stamps are required, and who will be held responsible for their safe custody, for their correction and issue to the proper Officers, and for their return in due course. The date-stamps would under this system be regarded as proper to particular duties rather than to particular Officers; and the same date-stamp could be used by different Officers succeeding each other on the same duty. Precautions should be taken to insure that date-stamps are not used by any unauthorised person or in any unauthorised way; and the arrangements should be such that it will be possible to ascertain, in the event of subsequent enquiry, what Officer was using a particular date-stamp at a particular time and date.
