Introduction

When an individual or company wishes to post a letter or parcel there are several methods open to them for the pre-payment of postage, the common way being the adhesive postage stamp.

It is the other options, however, that are dealt with here. They may be conveniently split into two divisions, namely:

PRE-PRINTED ENVELOPES

Section 1 - Official Postal Stationery

Used by the postal authorities on official correspondence.

Note: for the purpose of completeness unstamped stationery has also been included in the listings.

Section 2 - Postage Paid Impressions

Used by Government Departments and private companies on their bulk mailings.

Section 3 - Business Reply Service

Enables a customer to post a letter in one of the specially printed envelopes without charge, with the company picking-up the bill for the postage upon delivery at their premises.

POSTAL MARKINGS

Section 4 - Postal Franking Machines

Sold or hired-out to companies to enable them to frank their own mail.

Section 5 - Bulk Posting Cancellations

Unstamped mail is handed in at the Post Office together with a cash sum to cover the postage and either a hand cancellation or machine cancellation is applied indicating that postage has been paid.

1 - OFFICIAL POSTAL STATIONERY

When the Guernsey and Jersey Post Offices were set-up it was normal practice in those early days to affix postage stamps or to apply a bulk posting cancellation on all outgoing mail. Plain unprinted or specially printed stationery bearing a return address was used.

However, in the case of Guernsey it became apparent that with postal independence looming ahead and the number of requests for information packs increasing daily, it would be necessary to prepare pre-stamped stationery in order to save precious staff time.

Consequently a Map frank design (type GF1) was introduced on registered and unregistered envelopes and adhesive labels. These were subsequently replaced by an Arms frank design (types GF2 serif and GF3 non-serif). There were numerous variations in the typesettings and shades of paper used whenever a fresh printing was required.

During 1980 the Guernsey Post Office adopted a new image. Consequently a range of stationery was gradually introduced which incorporated their new 'logo' and blue and gold colour scheme (type GF4).

Jersey chose to wait until 1974 before she introduced pre-stamped stationery, when a range of envelopes was brought into use to coincide with the switch to computerised accounting.

To begin with a rather insignificant frank (type JF1) was used. This was swiftly altered to a boxed impression with a heavier type-face and larger letters (type JF2). The current Arms frank design (type JF3) bears an uncanny resemblance to the Guernsey type GF2.

The symbol (type JS1) that appears on some of the envelope flaps is colour coded red and black for DPA and Philatelic Bureau use, and olive green and black for use by the Director and Postal Committee.

It is apparent that the Jersey Post Office is gradually swinging away from the use of black printing in favour of red on its stationery.

As a matter of interest one rule contained in the Guernsey Post Office Guide states :

Use of Cut-out postage stamps

The postage paid design which is used on official stationery is not valid if cut-out from the cover, label or form on which it is printed.

The writer has yet to see any impressions printed on forms.

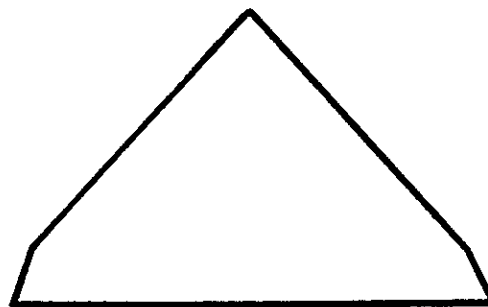
EXPLANATION OF CODES USED IN LISTINGS

Under each envelope, postcard or label heading are, for example, the words 'Each envelope bears (a), (c) and (n)'.

An explanation of these codes follows.

- (a) Address details or Post Office title at bottom left.
- (b) Address details or Post Office title on left hand half.
- (c) Address details along bottom edge.
- (d) Address details on flap.
- (e) Address lines in bottom right quarter.
- (f) Post Office symbol at top left.
- (g) Post Office symbol on flap.
- (h) Reference number at bottom right.
- (i) Reference number at top left.
- (j) Crossed registration lines.
- (k) The inscription 'For Official / Registration Label' at top left.
- (l) 'FIRST CLASS' at top left.
- (m) 'PLEASE DO NOT BEND' along bottom edge.
- (n) Postage Paid frank at top right.

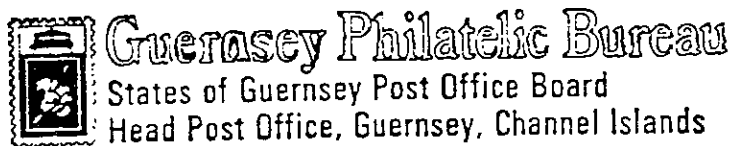

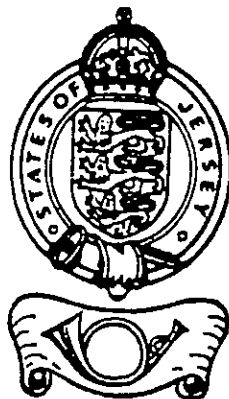

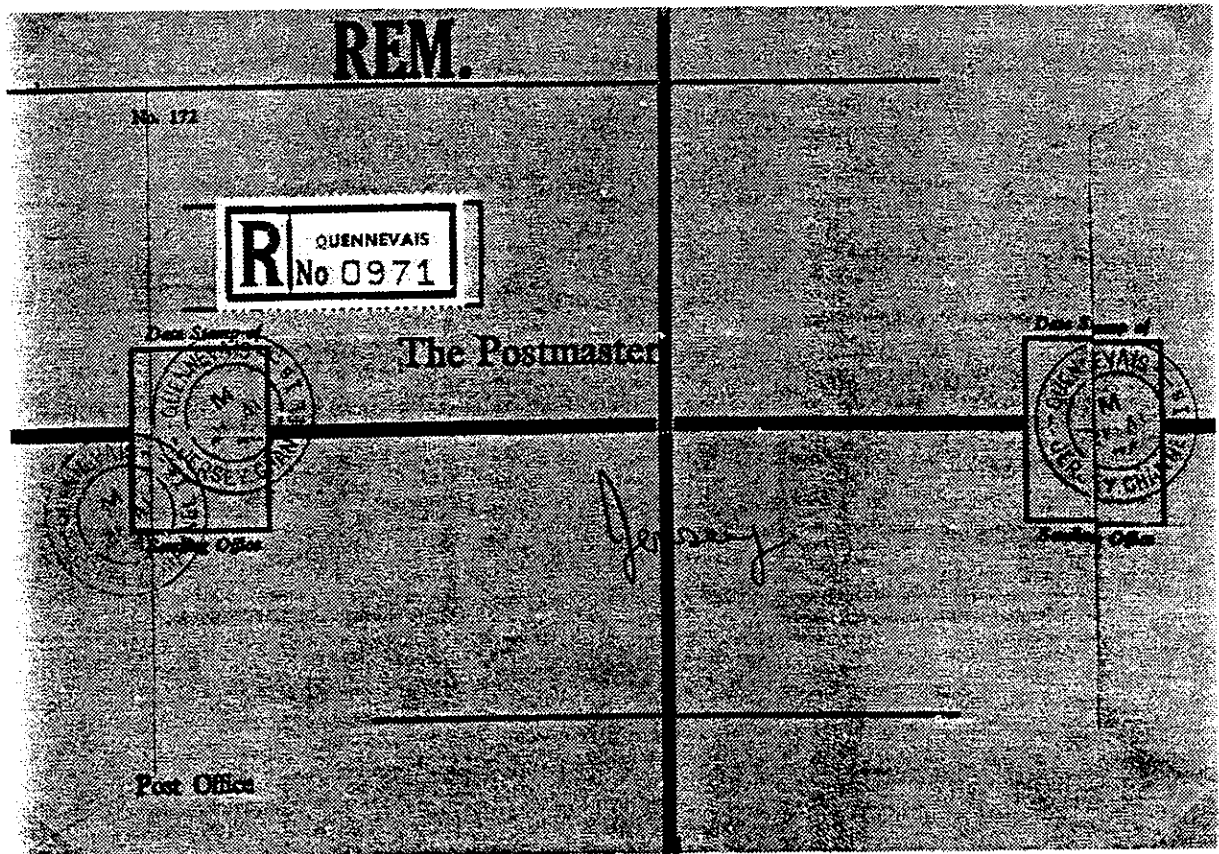
REMITTANCE ENVELOPES

These envelopes are used by the Jersey (and Guernsey?) Post Office(s) for the transmission of excess cash from the various sub offices to Head Office.

They are both British Post Office stock items and very few exist in collectors hands and are mentioned here for the purpose of completeness.

- The envelopes bear (a) crossed registration lines front and back,
- (b) 'Post Office' at bottom left,
 - (c) 'No. 172' or 'No. 446' and a space for a registration label alongside the letters REM at top left,
 - (d) 'The Postmaster' and two address lines in the middle of the envelope, and
 - (e) 'Date Stamp of / Sending Office' at the left and right sides halfway down the envelope.

Printing is in dark blue in accordance with registration regulations.



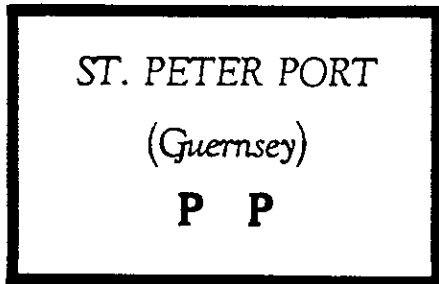

They are used by Government Departments or companies on their bulk mailings.

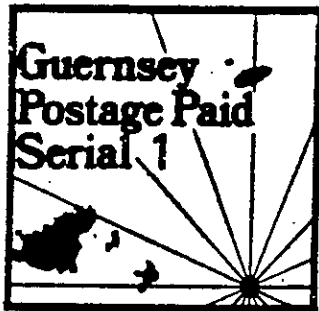

Section 3 - Business Reply Service

The Post Office Guide describes the service and conditions relating to the Business Reply Service and I feel that I can do no better than to quote from it.

DESCRIPTION

Under this service a person who wishes to obtain a reply from a client without putting him to the expense of paying postage may enclose in his communication an unstamped reply card, letter card, envelope, folder or gummed label of the special design shown below. He may also incorporate in his advertisements in newspapers and other publications a special design to be used as an address label or as a folder. It must be remembered, however, that folders are outside the preferred (POP) range and are therefore liable to attract additional postage as non-POP items. The client can post the card, etc., in the ordinary way, but without a stamp; and the licensee will pay the charges on all replies he receives.

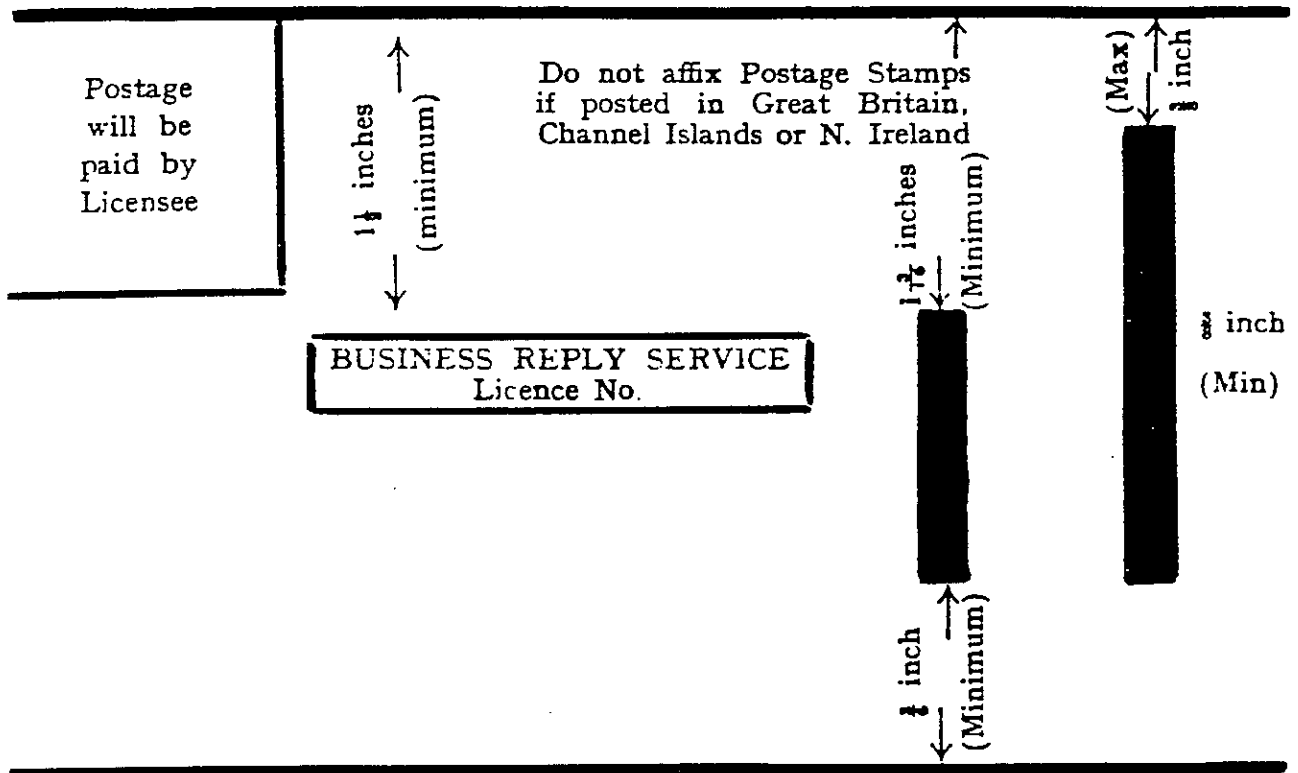
This service does not extend to the Irish Republic.

CONDITIONS

Licence. Before any person uses business reply cards, etc., a licence must be obtained from the Director of Postal Services; the fee for such a licence is £xx per annum.

Deposit. The licensee will be required to pay in advance a sum of money (normally £x) sufficient to cover the amount of the charges likely to accrue during a period of approximately one month and when the sum so paid is exhausted or nearly exhausted, the licensee will be required to make a further payment to renew his credit.

Design of cards, etc. Complete printed proofs of the cards, etc., (or, exceptionally, finished drawings of actual size, if the cards, etc., are to be printed from plates) conforming to the following design and relative other detail given at 1 to 10 below, must be forwarded to the Director of Postal Services for approval:



1. The design must not be less than 4 inches long by $2\frac{3}{4}$ inches wide.
2. The name and full postal address of the licensee must be printed parallel to the length of the card, etc., below the address panel containing the licence number. The address must be clear and correct with the name GUERNSEY / JERSEY printed in BLOCK capitals.
3. A space of not less than $1\frac{1}{2}$ inches must be left between the top edge and the top of the licence number panel.
4. The words "Do not affix postage stamps if posted in Great Britain, the Channel Islands or Northern Ireland" must be printed at the top of the card.
5. The words "Postage will be paid by licensee" must be printed in the top left-hand corner. The name of the licensee may be used instead of the word "Licensee".
6. There must be two wide vertical lines near the right-hand edge. Nothing other than the design, licence number and address may appear on the address side.
7. The design and address should preferably be printed in black but any deep colour (for example green, blue or brown), except red, orange or yellow, will be accepted provided that the printing is in strong contrast to the colour of the card or paper.
8. Labels must be printed on paper which will readily take an adhesive substance and which is not too thick to prevent the label being securely pasted down.

9. Cards must be of material not less than 1/100th inch thick.
10. Folders must, where possible, be so arranged that there are folds above and to the right of the top right-hand corner of the address side. Flimsy paper is not suitable for folders.

N.B. The Director of Postal Services should be asked to verify that the address which it is proposed to use is satisfactory.

Fees. A fee of xp. in addition to the normal postage will be charged on each card, etc., returned by post to the licensee.

Miscellaneous Conditions. In other respects business reply cards, etc., will be subject to the general regulations relating to the letter post.

As of July 1979 there were 48 Business Reply Service licences in use in Guernsey. Figures for Jersey are unknown but must be in excess of Guernsey in view of Jersey being the more important business centre.

On the occasion of the Jersey Post Office's tenth anniversary celebrations in 1979 a Business Reply Service envelope was despatched to each account holder living in Great Britain, the Channel Islands and Northern Ireland to enable them to apply for a special commemorative postcard without incurring postage. The licence number was JE304 which represented the old British Post Office telegraphic code for Jersey.

A second item, this time a postcard, was issued in 1980 when the Jersey Post Office in association with the Royal Society for the Prevention of Accidents (ROSPA) gave away reflector badges to Jersey school children to help protect them on the roads at night. They were also distributed at the International Philatelic Exhibition LONDON 1980 on both the Philatelic Bureau stand and the Little Licking Station junior section.

Section 4 Postal Franking Machines

Postal franking machines print impressions of various values directly on to envelopes, wrappers, labels, etc., and record the amount expended by means of a meter.

The Suppliers

Two companies supply the Channel Islands with franking machines, namely Pitney Bowes Limited (who supply on a hire agreement), and Roneo-Neopost Limited (who sell their machines outright to customers).

Acral Limited, Hasler (GB) Limited and Singer Company (UK) Limited Friden Division are licensed by both the Guernsey and Jersey Post Offices although no such machines have ever been used.

Both Pitney Bowes and Roneo-Neopost provide a range of models suited to the small and large mailer and have been hand driven or electrically operated over the years.

Post Office Conditions of Use

Users of these machines must conform to the following Post Office conditions:

- 1 They must obtain a licence from the Head Post Office.
- 2 Payments in advance in respect of postage must be made from time to time at the Head Post Office, where the machine must be presented for meter setting or registering.
- 3 The correspondence franked by the machine must be faced, securely tied in bundles (certain separations are required) and handed in at a specified Post Office - not necessarily the Head Post Office. Postings can ordinarily be made only at the specified Post Office, but under certain conditions it is permissible to post mail in special envelopes in posting boxes. Enquiries regarding these conditions should be addressed to the Director of Postal Services.
- 4 At the end of every week, whether the franking machine has been used or not, a control card must be tendered showing the reading of the meter or meters of the machine at the end of each weekday.
- 5 Licensees are required to have the machine inspected and maintained not less frequently than twice in each period of six months by the manufacturers or their agent so that such repairs as may be necessary may be effected to ensure the machine makes clear and distinct franking impressions and complete accuracy in recording.

- 6 Machines must be hired or purchased from the following companies licensed by the Post Office: Pitney Bowes Limited, Acral Limited, Hasler (GB) Limited, Roneo-Neopost Limited or the Singer Company (UK) Limited Friden Division.

Enquiries about the supply of franking machines and the types available should be directed to these firms.

The Impressions

The meter impressions are made-up of three separate sections:

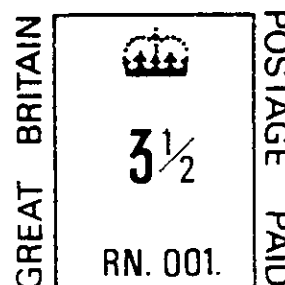
- 1 **The Slogan**
This is an optional facility and can be incorporated or left off at will.
- 2 **The Town Mark**
This part includes the datestamp, which is set at the commencement of each day by the user.
- 3 **The Value Die**
This shows the amount of postage paid, model prefix, licensee number, country of origin and a design incorporating the Royal Cypher, Crest or similar pattern.

Types of Franking Machines and Value Dies

Franking machines can be divided into three groups:

- 1 **Fixed Value**
Each value is printed from a separate die, of which the value is an integral part.
- 2 **Limited Value**
These machines are fitted with a single frame die, with a limited amount of separate value dies.
- 3 **Multi-Value**
These machines are also fitted with a single frame die in which any number of values can be printed. The total amount of variations depends on the number of banks, i.e. two banks will print from 0½p to 9½p, three banks 00½p to 99½p, four banks 000½p to 999½p, etcetera.

Colour of Impressions

The colour officially recognised by the Universal Postal Union is red and all impressions struck in the Channel Islands have been this colour. However, many shades of red have been used over the years and extremes such as orange, pink and magenta have been seen. They are of no special significance though.

Specimens and Proofs

1 Specimens

These exist for advertising purposes and are often on advertisement cards of the manufacturer and incorporate SPECIMEN in place of the town mark.

2 Proofs

Often these have been obtained by favour of the user after the machine has been licensed, and when from multi-value machines they often show the value expressed as '00'.

Collecting Hints

No hard and fast rules can be laid down as to how meter impressions should be collected. However, it is hoped that the following notes may be of assistance.

1 Entires versus Cut-outs

It is generally agreed that they should be on entire cover or card, especially if they are air-mail, registered or rarer varieties.

If you are aiming for a complete collection it is impractical to retain the whole cover because with several hundred impressions in existence you would not be able to move for covers! Cut-outs are, therefore, quite acceptable.

If the licensee has not utilised the slogan part of the impression be sure to leave the appropriate blank space to the left of the town mark. A template can be produced for this purpose, which also helps to ensure neat work.

2 Collectable Impressions

All possible values from fixed value and limited value machines should be collected. Some are very hard to obtain due to the fact that few machines were fitted with them. It is not worth trying to collect all possible values from multi-value machines as this would involve anything up to two hundred impressions per machine.

3 Storage

Mounting impressions in identification number order has proved to be the best method.

Two methods of mounting the collection can be utilised, namely filing cards (as supplied by leading stationers) and Hagner stock sheets. If the large size filing cards are used it is possible to mount whole covers and cut-outs. It is also easy to slip in new impressions as you get them. The Hagner method is especially suited to cut-outs as up to eight impressions per side can be mounted. The only disadvantage comes when you wish to incorporate a new impression as it is necessary to re-arrange all subsequent copies.

LISTINGS

Each entry has seven different headings and the following notes should be read first before referring to the listings.

1 Machine Identification Number

Franking machines used on Guernsey and Jersey have a licensee identification number, for example Jersey M1 which was a Pitney Bowes Midget licensed to the Jersey New Waterworks Company Limited.

By checking the machine identification prefix it is therefore possible to establish the make and/or model type.

Brief details of Pitney Bowes models follows. Unfortunately Roneo Neopost machine details have proved to be rather elusive.

Pitney Bowes

[a] Midget

Introduced in April 1926. The Midget was light, simple to use and provided three values which could be chosen within a range of 1 to 25

units with a facility for repetition to build-up multiple postage rates. Each unit was generally equivalent to halfpence ($\frac{1}{2}$ d).

For identification purposes the letter M appeared in the centre of the die followed by the identity number, which commenced from 1 upwards for each town separately. The system obviated the need for excessively long identification numbers.

Production discontinued in 1953.

B) Simplex

Hand operated model with a range of values from 3D to 6 $\frac{1}{2}$ d (SX Minor), or $\frac{1}{2}$ d to 1s 0 $\frac{1}{2}$ d (SX Major).

The numbering system was S1 to S999, SA1 up. The range of capacity was from 1 to 25 units.

Production of the SX Major was discontinued in 1953.

[c] Automax

Introduced in 1957. The Automax was offered in several versions. The 803 with values up to 9s 11 $\frac{1}{2}$ d, the 804 up to 29s 11 $\frac{1}{2}$ d and a high value model up to 99s 11 $\frac{1}{2}$ d.

Impressions from the Automax machine were identified by the letter A in the value die.

[d] 5300 Series

The meters provided for denominations up to either 10s 11 $\frac{1}{2}$ d or 99s 11 $\frac{1}{2}$ d. The identification letters PB were given to the 5300 series originally. This was subsequently amended to PBT when Guernsey and Jersey went postally independent.

[e] 6300 Series

This series introduced a few months after decimalisation. They have a value range of $\frac{1}{2}$ to 99 $\frac{1}{2}$ and bear the identification code of PBL to retain the PB initials whilst distinguishing it from the 5300 series.

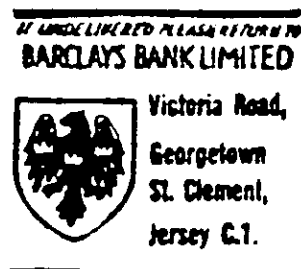
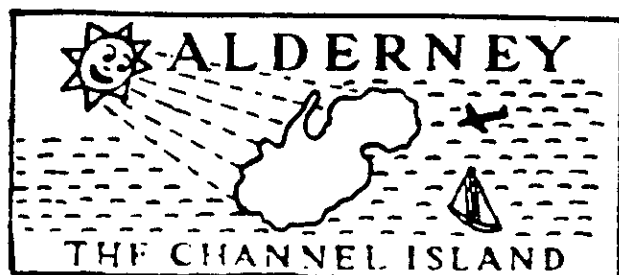

5 VALUE DIE

Great Britain Series

GB1.1 to GB4.2

With the amalgamation of Pitney Bowes and Universal Postal Frankers the opportunity was taken to introduce a new style value die, which Neopost also adopted.

Henry J Howard, a prominent philatelist and pioneer of meter impression collecting introduced the motif of the Crown with the Cypher of the reigning monarch. The words Great Britain and Post Paid were retained and the value was expressed once only in figures at the foot of the design which was surrounded by a frame of simulated perforations.

This design was to remain in production until 1959, only slight alterations being made for each successive sovereign.

GB4.3 to GB4.6

Neopost and Pitney Bowes were asked by the Post Office to change the design of the value die, which had been in use for over thirty years. As a result the Council of Industrial Design were consulted and Stuart Rose was nominated to prepare a design. The Queen approved the final choice and so production of dies was put in hand. The floral emblems of the United Kingdom - the English rose, the Scottish thistle, the Welsh daffodil and the Irish shamrock were surmounted by the Crown of St Edward the Confessor.

GB4.7

With the prospect of decimalisation it was decided to alter once more the value die used 'to accommodate the simpler expression of value'.

It consisted of a rectangular motif retaining the Crown, Great Britain and Postage Paid. It was to have a very short life as far as the Channel Islands went with the announcement of the decision to go postally independent.

Postal Independence

It was necessary for the value dies of every machine then in use in the islands to be altered to a design relevant to each Bailiwick. A moratorium of one month, with effect from 1 October 1969, was given for dies to be fitted to each of the 160 odd machines involved. The Guernsey and Jersey Post Offices gave a rough outline of their requirements and the manufacturers design studios set about preparing artwork.

Guernsey Series

John C. Mann of the British Meter Study Group describes the Guernsey design as 'showing a map of the island with its dependent islands of Alderney, Sark and Herm. Jethou shows up only on a clear impression. The value is shown in a gap in the series of radiating lines from a compass point at the bottom right hand corner of the frame'.

Jersey Series

E.C. Ehrmann describes the Jersey design of the Roneo-Neopost meters as 'a wavy lined square frame with the Crest at the top, the country name at the bottom'; whilst the Pitney Bowes machines consist of a 'rectangular pattern with Crest and country name at the top'.

6 Expression of Value

All machines prior to postal independence in 1969 were expressed in £sd, for example 1d, 1½d or 1s 6d. However, as new value dies were fitted the opportunity was also taken of preparing the machines for decimalisation. Therefore, between 1 October 1969 and 14 February 1971 values expressed as 1, 1½, or 18 meant 1d, 1½d, or 1s 6d; whilst from 15 February 1, 1½ or 18 means 1p, 1½p or 18p.

7 Dates Seen

Depending on the machine used the date can be numerical, e.g. 06. 08. 72 or numerical and roman combined, e.g. 06 VIII 72.

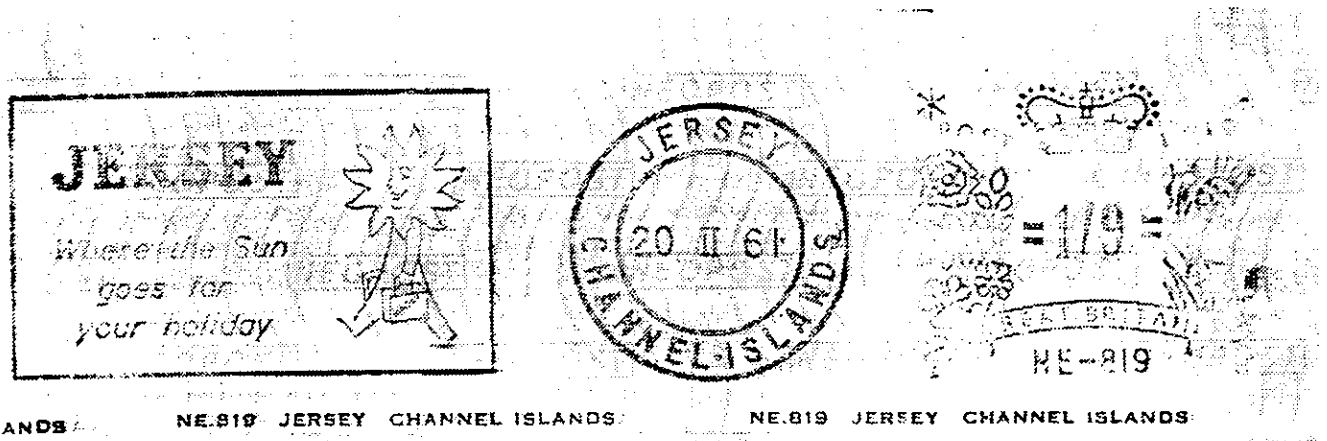
POST OFFICE PROVISIONAL MACHINE

1940 During the German occupation the General Post Office at St. Helier used a Neopost limited value machine number N8 previously licensed by Jersey Airways Limited. Originally it was fitted with a ½d die, which cracked vertically. The die was apparently repaired and later used as a ½d, 1d, 1½d or 2½d value. Its use was restricted to times when postage stamps were unobtainable. The clerk at the Post Office would accept letters and cash equivalent to the total postage and cancel each envelope with the meter frank.

ADHESIVES

Neopost safety paper tape exists printed in yellow on white gummed paper stock. Along the bottom edge is the machine number and JERSEY CHANNEL ISLANDS in black.

The only example seen by the writer comes from machine number NE-819.



INCOMPLETE IMPRESSIONS

When a franked item of mail has been posted with either an incomplete or faint impression a cachet is applied to this effect. A surcharge equivalent to double the letter rate is made

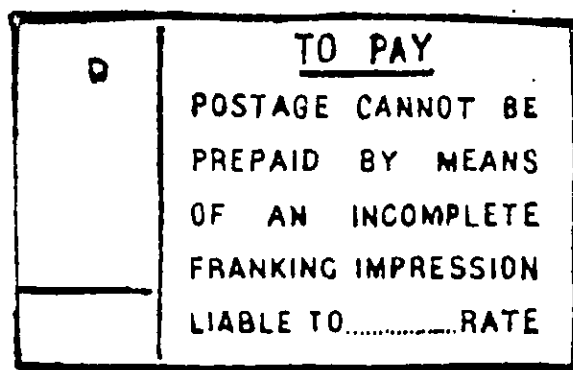

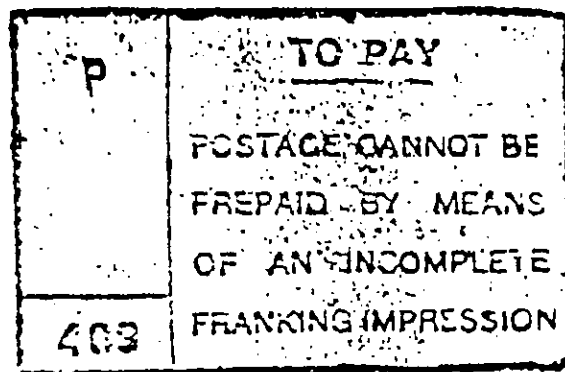

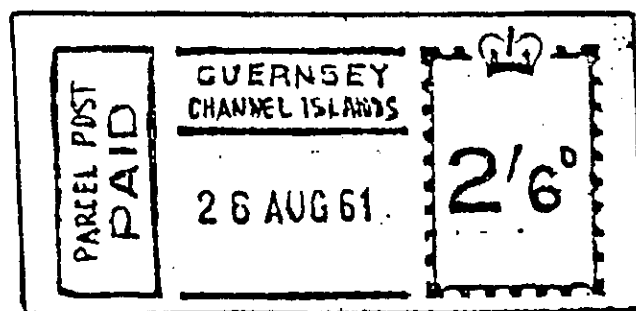

ADHESIVE PARCEL POST LABELS

The Head Post Offices of Guernsey and Jersey were supplied with a machine that printed and dispensed adhesive parcel post labels on 1 February 1960 and 26 October 1959, respectively.

It was necessary for the labels to be affixed to the parcel in the presence of the postal officer and so mint examples do not exist. Printed in red in denominations of 1d to 19s 11d, although parcel rates only are usually seen.

The experiment lasted only for a short time owing to its lack of success.

An interesting sideline collection of meter markings with Channel Island connections but used in the United Kingdom can be built-up if you keep your eyes open and examine the daily post.

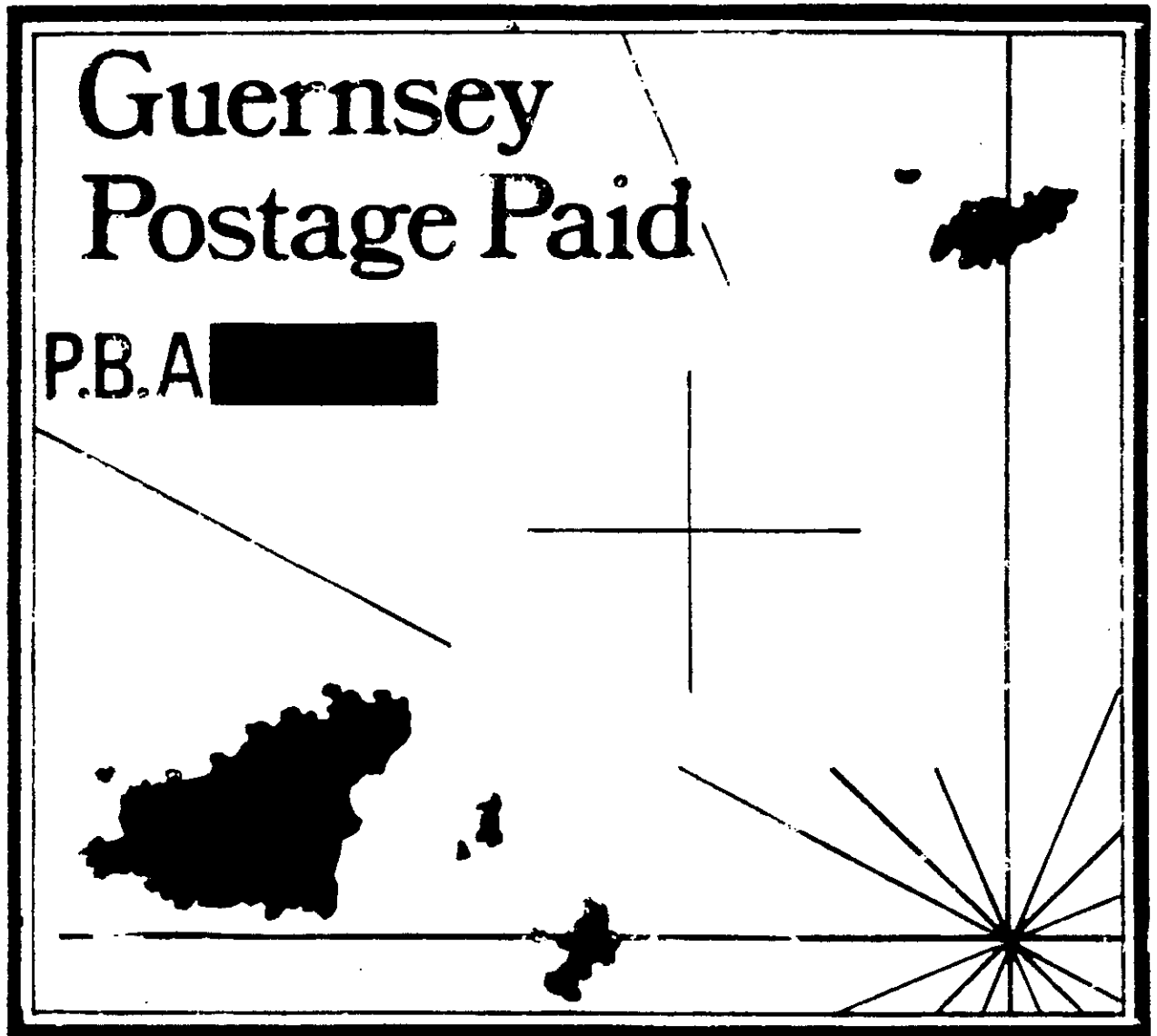

The 'New Image' style postal stationery had just been introduced when the author sent the manuscript for publication. An extra ten items can now be recorded and consequently Section 'M' in Volume 4, Number 2 should be disregarded.

It would appear that the use of gold for the lions proved either too difficult to apply or, more likely, too expensive for use on such mundane items as envelopes and labels. Aesthetically the move away from gold and blue to all-blue is a disappointment, but nevertheless understandable in these days of high costs.

Envelope M6 when first received appeared to be a missing colour error, but several examples have now been seen and must therefore have been an interim printing prior to going over to all-blue.
