Take notice that NL & GH Land of Great House Farm, Trellech Grange, Chepstow is applying to the Environment Agency for a licence to abstract water from anghidi farw at National Grid Ref SO 4944 0184 at Great House Farm, Trellech Grange, Chepstow, Monmouthshire. The proposal is to abstract water at the following rates: 9.5 cubic metres per hour, 228 cubic metres per day, 20,560 cubic metres (per year)—between November and March.

The water will be used to initially fill two fishing conservation pools. After the initial filling 75 cubic metres per day will be abstracted as a through flow to the pools. The water will return to the brook 375 metres downstream of the abstraction point.
