POST OFFICE SCHEME L2/1996

NOTE: The Scheme which follows this note is made under section 28 of the Post Office Act 1969 and amends the Post Office Overseas Letter Post Scheme 1982. The Scheme, which comes into operation on 8th July 1996 revises postal charges generally and introduces

definitions of Swiftair packets, prepaid Swiftpacks, Swiftair plus Registered Packets and Swiftair plus Recorded packets together with a scale of fees for these facilities. Additionally, the Scheme revises compensation levels for International Recorded and International Registered, acceptance conditions for International Registered and acceptance conditions relating to printed packets.

THE POST OFFICE OVERSEAS LETTER POST
AMENDMENT (NO. 16) SCHEME 1996

Made 1st July 1996

Coming into operation 8th July 1996

The Post Office, by virtue of the powers conferred on it by Section 28 of the Post Office Act 1969, and of all other powers enabling it in this behalf, hereby makes the following Scheme:

COMMENCEMENT AND CITATION

- 1.- (1) This Scheme shall come into operation on 8th July 1996 and may be cited as the Post Office Overseas Letter Post Amendment (No. 16) Scheme 1996.
2. This Scheme shall be read as one with the Post Office Overseas Letter Post Scheme 1982 (Post Office Scheme P2/1982) (hereinafter called "the Scheme") as amended by the Post Office Overseas Letter Post Amendment (No. 1) Scheme 1982 (Post Office Scheme P6/1982), the Post Office Overseas Letter Post Amendment (No. 2) Scheme 1983 (Post Office Scheme P4/1983), the Post Office Overseas Letter Post Amendment (No. 3) Scheme 1984 (Post Office Scheme 3/1984), the Post Office Overseas Letter Post Amendment (No. 4) Scheme 1985 (Post Office Scheme 4/1985), the Post Office Overseas Letter Post Amendment (No. 5) Scheme 1986 (Post Office Scheme 2/1986), the Post Office Overseas Letter Post Amendment (No. 7) Scheme 1987 (Post Office Scheme 2/1987) the Post Office Overseas Letter Post Amendment (No. 8) Scheme 1988 (Post Office Scheme 3/1988), the Post Office Overseas Letter Post Amendment (No. 9) Scheme 1989 (Post Office Scheme L2/1989), the Post Office Overseas Letter Post Amendment (No. 10) Scheme 1990 (Post Office Scheme L1/1990) the Post Office Overseas Letter Post Amendment (No. 11) Scheme 1991 (Post Office Scheme L1/1991), the Post Office Overseas Letter Post Amendment (No. 12) Scheme 1991 (Post Office Scheme L2/1991), the Post Office Overseas Letter Post Amendment (No. 13) Scheme 1991 (Post Office Scheme L3/1991), the Post Office Overseas Letter Post Amendment (No. 14) Scheme 1993 and the Post Office Overseas Letter Post Amendment (No. 15) Scheme 1993 (Post Office Scheme L8/1993).

INTERPRETATION

2. (1) In sub-paragraph (1) of paragraph 3 of the Scheme as subsequently amended, the following definitions shall be inserted after "small packet":

"Swiftair packet" means an outgoing postal packet bearing a special label to indicate the desire of the sender that the packet should receive accelerated treatment within the United Kingdom and the destination country".

"Swiftpack" means a prepaid outgoing postal packet consisting of specially designated plastic envelope provided by the Post Office, use of which indicates the desire of the sender that the packet should receive accelerated treatment within the United Kingdom and the destination country".

"Swiftair plus Registered" means an outgoing postal packet bearing a special label provided by the Post Office to indicate the desire of the sender that the packet should receive accelerated treatment within the United Kingdom and the destination country and that the packet should be

transmissible as an Insured packet under the terms of the Universal Postal Union Convention for the time being in force and the Detailed Regulations made thereunder".

"Swiftair plus Recorded" means an outgoing postal packet bearing a special label provided by the Post Office to indicate the desire of the sender that the packet should receive accelerated treatment within the United Kingdom and the destination country and that the packet should be transmissible as a Registered packet under the terms of the Universal Postal Union for the time being in force and the Detailed Regulations made thereunder".

AIR MAIL PACKETS

3. In sub-paragraph (b) of paragraph 9 of the Scheme as subsequently amended, the amount of "19p" shall be deleted and "20p" inserted in its place.

PRINTED PACKETS

- 4.- (1) Sub-paragraph (4) of paragraph 22 of the Scheme as subsequently amended shall be deleted and the following shall be substituted:
- "(4) A printed packet may be sent unenclosed without wrapper or envelope if it satisfies the rules and conforms to the limits of size applicable to postcards".
- (2) Sub-paragraphs (5) and (6) of paragraph 22 of the Scheme as subsequently amended and sub-paragraph (8) of paragraph 22 of the Scheme as substituted by the Post Office Overseas Letter Post Amendment (No. 12) Scheme 1991 shall be deleted.

ACCELERATED TREATMENT AND EXPRESS DELIVERY

5. For paragraph 29 of the Scheme as subsequently amended, there shall be substituted the following:

"Accelerated treatment - Swiftair packets, Swiftair plus Registered packets, Swiftair plus Recorded packets and Swiftpacks"

- 29.- (1) Upon every Swiftair packet, there shall be charged and paid the fee of £2.70, in addition to postage and any other fees charged and payable thereon.
- (2) Upon every Swiftair plus Registered packet, there shall be charged and paid the fees specified in Part 1 of Schedule 5A, in addition to postage and any other fees charged and payable thereon.
- (3) Upon every Swiftair plus Recorded packet, there shall be charged and paid the fees specified in Part 2 of Schedule 5A, in addition to postage and any other fees charged and payable thereon.
- (4) Upon every Swiftpack, there shall be charged and paid the fees specified in Part 3 of Schedule 5A.
- (5) Swiftair packets, Swiftair plus Registered packets, Swiftair plus Recorded packets and Swiftpacks shall be posted by being handed to an officer of the Post Office and shall be segregated from all other postal packets".

COMPENSATION FOR REGISTERED PACKETS

- 6.- (1) In sub-paragraph (2)(a) of paragraph 33 of the Scheme as subsequently amended, the amount "£500" shall be deleted and "£1500" inserted in its place.
- (2) In sub-paragraph (2)(b) of paragraph 33 of the Scheme as subsequently amended, the amount "£25" shall be deleted and "£28" inserted in its place.

INSURED LETTERS

- 7.- (1) In sub-paragraph (1)(c) of paragraph 35 of the Scheme as subsequently amended, the following words shall be added following the words "the same private mark of the sender":
- "and where transparent adhesive tape is used to seal the envelope or packing, the private mark of the sender shall be applied directly to the closing join or flap before the transparent adhesive tape is applied".
- (2) In sub-paragraph (1)(d) of paragraph 35 of the Scheme as subsequently amended, the amount "£1000" shall be deleted and "£2200" inserted in its place.

COMPENSATION FOR INSURED LETTERS

8. In sub-paragraphs (2) and (3) of paragraph 36 of the Scheme as subsequently amended, the amounts "£1000" shall be deleted and "£2200" inserted in their place.

COMPENSATION FOR CERTAIN OTHER POSTAL PACKETS

9. In sub-paragraph (2) of paragraph 37 of the Scheme as subsequently amended, the amount "£25" shall be deleted and "£26" inserted in its place.
