Coming into operation 26 May 2006

Royal Mail Group plc ^(a) by virtue of the powers conferred upon it by section 89 of the POSTAL SERVICES ACT 2000^(b) and of all other powers enabling it in this behalf, hereby makes the following Scheme:

Commencement, citation and interpretation

- This amendment to the Scheme shall come into operation on 26 May 2006 and may be cited as the Royal Mail Group plc Overseas Letter Post Amendment (No.12) Scheme 2006.
- This amendment to the Scheme shall be read as one with the Successor Postal Services Company Overseas Letter Post Scheme 2001^(c) (hereinafter called "the Scheme") as amended by the Consignia plc Overseas Letter Post Scheme Amendment (No.1) 2001,^(d) the Consignia plc Overseas Letter Post Scheme Amendment (No.2) 2001,^(e) the Consignia plc Overseas Letter Post Scheme Amendment (No.3),^(f) the Consignia plc Overseas Letter Post Scheme Amendment (No.4) 2002,^(g) the Royal Mail Group plc Overseas Letter Post Scheme Amendment (No.5) 2002,^(h) the Royal Mail Group plc Overseas Letter Post Scheme Amendment (No.6) 2003,⁽ⁱ⁾ the Royal Mail Group plc Overseas Letter Post Scheme Amendment (No.7) 2003,^(j) the Royal Mail Group plc Overseas Letter Post Scheme Amendment (No.8) Scheme 2003, ^(k) the Royal Mail Group plc Overseas Letter Post Scheme Amendment (No.9) Scheme 2004 ^(l), the Royal Mail Group plc Overseas Letter Post Scheme Amendment (No.10) ^(m) and the Royal Mail Group plc Overseas Letter Post Scheme Amendment (No.11)⁽ⁿ⁾.
- A reference in this Scheme to the Successor Postal Services Company shall be read as a reference to Royal Mail Group plc.

1. Paragraph 32A. Sending Airsure Packets, Airsure Packs, International Signed For Packets and International Signed For Packs

Delete sub-paragraph 32A (2), sub-section (iii) and replace with the following:

'(iii) The sum of £250 or £500 depending on the amount of compensation payable which the Post Office may from time to time determine for such packets or packs to particular destinations, or'

and add sub-section (iv)

'(iv) The sum of £100 should the contents include coins, bank notes, currency notes or securities of any kind payable to bearer and travellers cheques where such items are permitted to be sent, or'

and add sub-section (f)

'(f) Additional compensation options cannot be purchased for packets

containing mobile telephones'. The maximum compensation payable is specified at Paragraph 38.

2. Paragraph 37A. Compensation for Airsure Packets, Airsure Packs, International Signed For Packets and International Signed For Packs.

Insert the following sub paragraphs:

(1a) The maximum amount of compensation which the Post Office will pay in respect of coins, bank notes, currency notes or securities of any kind payable to bearer and travellers cheques is limited to £100.

3. Paragraph 38. Compensation for Certain other Postal Packets

Delete sub paragraph (2) and replace with the following:

'(2) The total amount of compensation which the Post Office may pay under sub-paragraph (1) in respect of any one postal packet and its contents shall not in any case exceed £32.'

4. SCHEDULE 7

Delete 'Paragraphs 30 and 32A' and replace with:

'Subject to the conditions outlined in Paragraphs 30, 32A and 37A.'

THE WEIGHTS AND MEASURES (NORTHERN IRELAND) ORDER 1981

NOTICE UNDER ARTICLE 10

The Department of Enterprise, Trade and Investment^(a) by this Notice hereby directs pursuant to the provisions of Article 10(8) of the Weights and Measures (Northern Ireland) Order 1981 as follows:

Every certificate which has been granted after 9 February 2006 up to and including the day of this Notice by the Secretary of State in respect of any pattern of weighing or measuring equipment for the purposes of section 12 of the Weights and Measures Act 1985 shall be deemed for the purposes of the Weights and Measures (Northern Ireland) Order 1981 to be a certificate of approval of that pattern granted and published under Article 10 of the said Order of 1981.
