THE INLAND POST AMENDMENT (No. 6) WARRANT 1932

DATED MAY 13, 1932.

We, the Commissioners of His Majesty's Treasury, in exercise of the powers given to us by the Post Office Acts 1908 to 1920, and of all other powers enabling us in this behalf, do, by this Warrant, made on the representation of His Majesty's Postmaster General (testified by his signing the same) and under the hands of two of us, the said Commissioners, order, direct, and declare, as follows:—

- 1. This Warrant shall be read as one with the Inland Post Warrant 1923 (hereinafter called "the Principal Warrant") and all Warrants amending the same.
- **2.**—(1) The following definition shall be inserted in Regulation 64 (Definitions) of the Principal Warrant immediately after the definition of "printed packet":—

"Sample Packet."

- "(4A). The expression "sample packet" means a packet containing a specimen (without saleable value) of goods for sale:—
 - (a) either with or without any article or document transmissible as a printed packet, and
 - (b) either with or without a cover or label for the return of the sample to the dealer by whom the sample was originally posted".
- (2) In the definitions of "letter" and "postal packet" in Regulation 64 of the Principal Warrant the words "sample packet" shall be inserted after the words "printed packet".
- **3.** There shall be charged and paid on every sample packet the following rates of postage, that is to say:—

On every sample packet not exceeding four ounces in weight, one penny.

On every sample packet exceeding four ounces but not exceeding six ounces, three-halfpence. On every sample packet exceeding six ounces but not exceeding eight ounces, twopence.

- **4.** There shall not be posted or conveyed or delivered by post any sample packet the dimensions of which shall exceed twelve inches in length, eight inches in width or four inches in depth, or the weight of which shall exceed eight ounces.
- **5.**—(1) The cover of every sample packet shall bear the word "sample" written or printed thereon.
 - (2) Upon the outside of a sample packet or on the cover thereof there shall be printed in ordinary type, or by means of a hand stamp, the name and address of the dealer by whom the samples are sent.
 - (3) There shall not be enclosed in any sample packet any goods of any kind (however small the quantity) sent from a dealer to an actual or possible purchaser or from any person who is not a dealer to any other person.
 - (4) The provisions of Regulation 17 (Special Conditions as to printed packets) of the Principal Warrant shall apply to sample packets, with the exception of paragraph (g) of the Regulation.

- **6.**—(1) This Warrant shall come into operation on the 23rd day of May 1932.
 - (2) Sample packets shall not be transmitted between Great Britain and the Irish Free State.
- 7. This Warrant may be cited as "The Inland Post Amendment (No. 6) Warrant 1932."
