**THE FOREIGN AND COLONIAL PARCEL POST AMENDMENT  
(NO. 4) WARRANT, 1907. DATED APRIL 11, 1907.**

1907. No. 281.

We, the Commissioners of His Majesty's Treasury, in exercise of all powers given to us by the Post Office Acts or any of them, and of all other powers enabling us in this behalf, do, by this Warrant, made on the representation of His Majesty's Postmaster-General (testified by his signing the same) and under the hands of two of us, the said Commissioners, order, direct, and declare as follows:—

1. This Warrant may be cited as "The Foreign and Colonial Parcel Post Amendment (No. 4) Warrant, 1907." Short Title.
2. This Warrant shall be read as one with the Foreign and Colonial Parcel Post Warrant, 1906,\* and all Warrants amending the same. Warrant to be read with existing Warrants.
3. On every outgoing parcel addressed to Spain and transmitted *viâ* France, and on every outgoing parcel addressed to the Balearic Islands and transmitted *viâ* France, there shall be charged and paid the rates of postage specified against the names of such places respectively in the Schedule hereto. Rates on parcels to Spain and the Balearic Islands *viâ* France.
4. Except by permission of the Postmaster-General there shall not be forwarded, conveyed, or delivered by post under this Warrant any parcel the dimensions of which shall exceed the dimensions respectively specified in the Schedule hereto. Maximum dimensions.
