2. This Warrant shall be read as one with the Foreign and Warrant to Colonial Parcel Post Warrant, 1906,† and all Warrants amending the same.

3. On every outgoing parcel addressed to Chili and transmitted Rates on via Buenos Ayres and the Andes, there shall be charged and paid parcels to the rotes of postage aposified in Part I of the Calada bands. the rates of postage specified in Part I. of the Schedule hereto.

6. This Warrant shall come into operation on the 1st day of July, 1912.
