#### TREASURY WARRANT.

WE, the Commissioners of Her Majesty's Treasury, in exercise of all powers enabling us in this behalf, do by this Warrant made on the representation of Her Majesty's Postmaster-General (testified by his signing the same), and under the hands of two of us, the said Commissioners, order, direct, and declare as follows:—

1. All Treasury Warrants at any time heretofore made relating to the conveyance by post of postal packets (which term in this Warrant means and includes all letters, post cards, newspapers, packets of commercial papers, packets of printed papers, and pattern or sample packets), between the United Kingdom and Peru, and also between any British Colony or Foreign Country and Peru, are hereby repealed to the extent to which such Warrants respectively relate to the several matters comprised in this Warrant as aforesaid.

2. The rates of postage and additional sums for registration now chargeable and payable by the authority of the Treasury Warrant of the 29th day of May, 1879, or the schedules thereunder written, on postal packets conveyed or delivered for conveyance by post from or to Brazil, to or from any other country or place, and all regulations and conditions as to the posting, forwarding, conveyance, and delivery of postal packets con-

veyed or delivered for conveyance by post, now in force and applicable thereto shall extend and apply to all postal packets conveyed or delivered for conveyance by post from or to Peru to or from any other country or place in the same way as if Peru had been named in such before mentioned Warrant of the 29th day of May, 1879, or the schedules thereunder written.

3. This Warrant shall come into operation on the 17th day of June, 1879.

#### GENERAL ORDER Amendment of Regulations: District Schools:—

To the Boards of Management of the several School Districts named in the Schedule to this Order:—

And to all others whom it may concern.

WHEREAS by certain Orders, addressed by the Poor Law Commissioners, the Poor Law Board, and the Local Government Board, respectively, to the Board of Management of each of the School Districts named in the Schedule to this Order, provision is made for the appointment by such Board of Management, from time to time, of persons to hold certain offices, and amongst them the following; namely,—

Superintendent,	} of the School;
Matron,	
Schoolmaster,	
Schoolmistress,	

and the following regulations, or regulations to the like effect, are contained in or made applicable by the said Orders, with respect to the continuance in office of such Officers:

"Every Officer appointed by the Managers shall continue to hold his office until he shall die, or resign, or be removed by the Commissioners, or be proved in a manner satisfactory to the Commissioners, to be insane."

"If any Superintendent and Matron be husband and wife, and one of them be dismissed by Order of the Poor Law Board, or otherwise vacate his or her office, or die, the other, or survivor, shall, at the expiration of the then current quarter, cease to hold his or her office of Superintendent or Matron, as the case may be."

And whereas it is expedient that the regulations above recited should be altered as hereinafter mentioned:

Now therefore, we, the Local Government Board, in pursuance of the powers given to us by the statutes in that behalf, hereby Order as follows:—

ARTICLE I.—Instead of the regulations above recited, the following regulations numbered (1.) and (2.) respectively shall apply to the officers therein mentioned:—

(1.) Every Superintendent, Matron, Schoolmaster, and Schoolmistress of a District School, appointed after the twenty-fourth day of June, one thousand eight hundred and seventy-nine, shall continue to hold office until he or she die, or resign, or be dismissed by the Board of Management, subject to the consent of the Local Government Board, or by the Local Government Board, or be proved to be insane by evidence which that Board shall deem sufficient.
