

## (PLEURO-PNEUMONIA.)

AT the Council Chamber, Whitehall, the 10th day of July, 1883.

By Her Majesty's Most Honourable Privy Council.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The Place described in the Schedule to this Order is hereby declared to be a Place infected with pleuro-pneumonia.

2. This Order shall take effect from and immediately after the eleventh day of July, one thousand eight hundred and eighty-three.

A Place comprising the cow-houses and premises at Greenfield House farm, Bierley Lane, in the township of North Bierley, in the West Riding of the county of York, in the occupation of Charles Bentley.

## THE CONTAGIOUS DISEASES (ANIMALS) ACT, 1878.

## (FOOT-AND-MOUTH DISEASE.)

THE following Areas are now *Areas Infected with Foot-and-Mouth Disease* under the above-mentioned Act (except the lines of railway within those Areas as far as those lines are used or required for the transit of animals through those Areas, without untrucking):—

*Argyleshire.*—The united parishes of Kilmore and Kilbride, in the county of Argyle.

*Essex.*—At Rood Street, in the parish of Epping, in the county of Essex, comprised within the following boundaries, that is to say, the Great Eastern Railway and a wood known as Rough Tallies on the south, and thence over the main-road leading from Epping to Ongar taking three fields along the side thereof in the occupation of William Simmonds adjoining the said road, thence by an Old Green-lane to the road from Weald Church, continuing along that road towards and unto the main-road from Harlow to Epping, thence to Thornwood Gate, and including the whole of that part of Epping Forest known as Lower Forest.

*Lincolnshire (Holland).*—The whole of the Parts of Holland; the petty sessional divisions of Bourn, and Sleaford, in the Parts of Kesteven; and the whole of the borough of Boston; Lincolnshire.

*Lincolnshire (Kesteven).*—The whole of the Parts of Holland; the petty sessional divisions of Bourn, and Sleaford, in the Parts of Kesteven; and the whole of the borough of Boston; Lincolnshire.

## (SWINE-FEVER.)

THE following Areas are now *Areas Infected with Swine-Fever* under the above-mentioned Act (except the lines of railway within those Areas as far as those lines are used or required for the transit of swine through those Areas, without untrucking):—

*Buckinghamshire.*—So much of the hamlet of Weedon, in the parish of Hardwick, in the

county of Buckingham, as lies to the east or north-east of the main-road leading from Aylesbury to Buckingham, except the lands, yards, and outbuildings in the said hamlet as are in the occupation of Edward John Clift.

*Wiltshire.*—The petty sessional divisions of Calne, Chippenham, and Malmesbury, in the county of Wilts.

## TREASURY WARRANT.

WE, the Commissioners of Her Majesty's Treasury, in exercise of all powers enabling us in this behalf, do, by this Warrant, made on the representation of Her Majesty's Postmaster-General (testified by his signing the same), and under the hands of two of us, the said Commissioners, order, direct, and declare as follows:—

1. The rates of postage and additional sum for registration now chargeable and payable by the authority of the Treasury Warrant of the 13th day of December, 1882, or the schedules thereunder written on reply post cards conveyed or delivered for conveyance by post to Turkey from the United Kingdom, Malta, Gibraltar, and Tangier, and the British Post Offices in Constantinople, Smyrna, and Beyrout, respectively, and all regulations and conditions as to the posting, forwarding, conveyance, and delivery of reply post cards conveyed or delivered for conveyance by post now in force and applicable thereto shall extend and apply to all reply post cards conveyed or delivered for conveyance by post to Greece from the United Kingdom, Malta, Gibraltar, and Tangier, and the British Post Offices in Constantinople, Smyrna, and Beyrout, respectively, in the same way as if Greece had been named in the said Warrant of the 13th day of December, 1882, or the schedules thereunder written.

2. This Warrant shall come into operation on the thirteenth day of July, one thousand eight hundred and eighty-three.
