TREASURY WARRANT.

WE, the Commissioners of Her Majesty's Treasury, in exercise of all powers enabling us in this behalf, do by this Warrant made on the representation of Her Majesty's Postmaster-General (testified by his signing the same), and under the hands of two of us, the said Commissioners, order, direct, and declare as follows:—

1. All Treasury Warrants at any time heretofore made relating to the conveyance by post of postal packets (which term in this Warrant means and includes all letters, post cards, newspapers, packets of commercial papers, packets of printed papers, and pattern or sample packets) between the United Kingdom and the Kingdom of Siam, and also between any British Colony or Foreign Country and the Kingdom of Siam, are hereby annulled to the extent to which such Warrants respectively relate to the several matters comprised in this Warrant as aforesaid.

2. The rates of postage and additional sum for registration now chargeable and payable by the authority of the Treasury Warrants of the 14th day of January, 1880, and the 15th day of June, 1880, or either of them on postal packets conveyed or delivered for conveyance by post from or to the Straits Settlements, to or from any other country or place affected by the provisions of the said

Warrants or either of them, and all regulations and conditions now in force as to the posting, forwarding, conveyance, and delivery of postal packets conveyed or delivered for conveyance by post, between the Straits Settlements and any other country or place as aforesaid shall extend and apply to all postal packets conveyed or delivered for conveyance by post from or to the Kingdom of Siam, to or from any other country or place affected by the provisions of the said Warrants in the same way as if the Kingdom of Siam, had been named or referred to in the said Warrants and the schedules thereunder written in the same manner as the Straits Settlements are named or referred to therein.

3. This Warrant shall come into operation on the first day of July, one thousand eight hundred and eighty-five.

ORDER of the Local Government Board:—
Cholera Regulations.—(Rags from Spain.)

To all Port Sanitary Authorities;—
To all Urban and Rural Sanitary Authorities;—
To all Officers of Customs;—
To all Medical Officers of Health of the Sanitary Authorities aforesaid;—
To all Masters of Ships;—
And to all others whom it may concern.

WHEREAS Cholera is now prevalent in certain parts of Spain, and it is expedient that regulations should be made with reference to Ships having on board bales of Rags from that country:

Now therefore, We, the Local Government Board, do, by this Our Order, and in exercise of the power conferred on Us by Section 130 of the Public Health Act, 1875, and every other power enabling Us in this behalf, make the following regulations, and declare that they shall be enforced and executed by the Authority or Authorities hereinafter specified:—

ARTICLE 1. In this Order—

The term "Sanitary Authority" means Port Sanitary Authority, Urban Sanitary Authority, or Rural Sanitary Authority;

The term "Ship" includes vessel or boat;

The term "Officer of Customs" includes any person acting under the authority of the Commissioners of Customs;

The term "Master" includes the officer or person for the time being in charge or command of a ship.

ARTICLE 2. From and after the date of this Order, and until the first day of November, 1885, no rags from Spain shall be delivered overside, except for the purpose of export, nor landed in any port or place in England or Wales.

ARTICLE 3. If any rags shall be delivered overside or landed in contravention of this Order, they shall, unless forthwith exported, be destroyed by the person having control over the same with such precautions as may be directed by the Medical Officer of Health of the Sanitary Authority within whose jurisdiction or district the same may be found.

ARTICLE 4. All masters of vessels, consignees, and other persons having control of any rags prohibited under this Order from being delivered overside, except for the purpose of export, or landed, are required to obey these regulations.

ARTICLE 5. All Officers of Customs are empowered to prevent the delivery overside or landing of rags in contravention of this Order.

ARTICLE 6. It shall be the duty of the Sanitary Authority to take proceedings against masters of ships, consignees, or other persons having control over any rags, who shall wilfully neglect or refuse to obey or carry out, or shall obstruct the execution of any of these regulations.
