THE POST OFFICE INLAND POST AMENDMENT (No. 3) SCHEME 1973

16th October 1973 Made -Coming into operation : 1st November 1973

The Post Office, by virtue of the powers conferred upon it by section 28 of the Post Office Act 1969, and all

other powers enabling it in this behalf, hereby makes the following Scheme:

Commencement, citation, interpretation and revocation

- 1.—(1) This Scheme shall come into operation on 1st November 1973 and may be cited as the Post Office Inland Post Amendment (No. 3) Scheme 1973.
- (2) This Scheme shall be read as one with the Post Office Inland Post Scheme 1972 (Post Office Scheme P7/1972) (hereinafter called "the Scheme"), as amended by the Post Office Inland Post Amendment (No. 1) Scheme 1973 (Post Office Scheme P1/1973), and the Post Office Inland Post Amendment (No. 2) Scheme 1973 (Post Office Scheme P10/1973).
- (3) The Interpretation Act 1889 applies for the interpretation of this Scheme as it applies for the interpretation of an Act of Parliament and as if this Scheme were an Act of Parliament.
- 2. Paragraph 54 of, and Schedule 5 to, the Scheme, are hereby revoked.
