# THE POST OFFICE INLAND POST AMENDMENT (No. 1) SCHEME 1979

Made ... .. 13th July 1979 Coming into operation 20th August 1979

The Post Office, by virtue of the powers conferred upon it by section 28 of the Post Office Act 1969, and all other powers enabling it in this behalf, hereby makes the following Scheme:

# Commencement, citation and interpretation

- 1.—(1) This Scheme shall come into operation on 20th August 1979 and may be cited as the Post Office Inland Post Amendment (No. 1) Scheme 1979.
- · (2) This Scheme shall be read as one with the Post Office Inland Post Scheme 1979 (Post Office Scheme P1/1979) (hereinafter called "the Scheme").
- (3) The Interpretation Act 1978 applies for the interpretation of this Scheme as it applies for the interpretation of an Act of Parliament and as if this Scheme were an Act of Parliament.
- 2. In sub-paragraph (1) of paragraph 3 of the Scheme in the definition of "minimum registration fee" the word "smallest" shall read "smaller".

# Redirection by the public

3. In sub-paragraph (3) (b) of paragraph 32 of the Scheme the figure "9p" shall read "10p".

### Registration

4. In sub-paragraph (2) of paragraph 37 of the Scheme the words "one of the higher registration fees" shall be deleted and the words "the higher registration fee" inserted in their place.

### Compulsory Registration

5. In sub-paragraph (3) of paragraph 40 of the Scheme the figure "9p" shall read "10p" and the words "highest registration fee which the said excess amount covers," shall be deleted and the words "higher registration fee if covered by the said excess amount," inserted in their place.
