- "(ii) any imitation of a bank note, if such bank note is one within the meaning of section 38 of the Criminal Justice Act 1925 and is for the time being legal tender in the country of issue;

3. In sub-paragraph (8) of paragraph 12 of the Scheme, after the word "No" and before the words "stamp or impression" there shall be inserted the words "impression which is imperfect, and no", and the words "imperfect or" shall be deleted in both places where they occur.

Services not available for packets to and from the Channel Islands, the Isle of Man or the Republic of Ireland

- 4. Paragraph 58 of the Scheme shall be deleted and the following inserted in its place:
- "58. The service relating to express packets, in so far as it provides for the conveyance of such a packet by special messenger throughout the whole or part of its course in the post, and the Royal Mail Special Delivery service shall not be available for packets posted for transmission between the British postal area and the Channel Islands, the Isle of Man or the Republic of Ireland."

Compensation for certain postal packets to and from the Channel Islands, the Isle of Man and the Republic of Ireland

5. In paragraph 67 of the Scheme as subsequently amended, after the words "shall be £17." there shall be inserted the following: "In the case of a Datapost packet posted for transmission between the British postal area and the Republic of Ireland, no compensation shall be payable.

6. Sub-paragraph (4)(b) of paragraph 3 of Part II of Schedule 5 to the Scheme shall be deleted and the following inserted in its place:

"(b) there shall not be enclosed in any one postal packet coin of the United Kingdom of £1 denomination of a total value in excess of £25, or coin of any country of any other denomination of a total value in excess of £5, except in a case where the value of each coin exceeds its face value.

7. The following shall be inserted after paragraph 6 of Schedule 8A to the Scheme:

"7. On the posting of the packet a certificate of posting shall be obtained."
