POST OFFICE SCHEME 6/1986

Note: The Scheme which follows this note has been made under Section 28 of the Post Office Act 1969 and amends the Post Office Inland Post Scheme 1979. The Scheme, which will come into operation on 20th October 1986, provides for alterations to letter post rates, fees and compensation limits, and for the cessation of those provisions of the Inland Post Scheme applying to the Republic of Ireland.

THE POST OFFICE INLAND POST AMENDMENT (NO. 18) SCHEME 1986

... 15th September 1986 Coming into operation 20th October 1986

The Post Office, by virtue of the powers conferred upon it by Section 28 of the Post Office Act 1969, and all other powers enabling it in this behalf, hereby makes the following Scheme:

Commencement and citation

1.—(1) This Scheme shall come into operation on 20th October 1986 and may be cited as the Post Office

Interpretation

2. In sub-paragraph (1) of paragraph 3 of the Scheme, in the definition of "incoming", the words "the Isle of Man or from the Republic of Ireland" shall be deleted and the words "or from the Isle of Man" inserted in their place.

Application

3.—(1) In sub-paragraphs (a) and (c) of paragraph 4 of the Scheme, the words "the Isle of Man or in the Republic of Ireland" shall be deleted and the words "or in the Isle of Man" inserted in their place.

(2) In sub-paragraph (2) of paragraph 4 of the Scheme, the words "Isle of Man or the Republic of Ireland" shall be deleted and the words "or the Isle of Man" inserted in their place.

Express delivery

4. In sub-paragraph (6) of paragraph 28 of the Scheme, the words "the Isle of Man or the Republic of Ireland" shall be deleted and the words "or the Isle of Man" inserted in their place.

Redirection by the public

5. In sub-paragraph (1) of paragraph 32 of the Scheme, the words "the Isle of Man or the Republic of Ireland" shall be deleted in both places where they occur, and the words "or the Isle of Man" inserted in their place.

Packets for which the Post Office accepts liability

6. In sub-paragraph (6) of paragraph 36A of the Scheme, the words "the Isle of Man or the Republic of Ireland" shall be deleted and the words "or the Isle of Man" inserted in their place.

Compulsory registration

7. In sub-paragraph (2) of paragraph 40 of the Scheme as subsequently amended, "£18" shall read "£20".

Compensation for certain other postal packets

- 8.—(1) In sub-paragraph (3) of paragraph 47 of the Scheme as subsequently amended, "£18" shall read "£20".
 - (2) In sub-paragraph (5) of paragraph 47 of the Scheme, "paragraph 5" shall read "paragraph 8".

Application generally

9. In paragraph 57 of the Scheme, the words "the Isle of Man or the Republic of Ireland" shall be deleted and the words "or the Isle of Man" inserted in their place.

Services not available to and from the Republic of Ireland

10. Paragraph 59 of the Scheme shall be deleted.

No rebate postings to the Channel Islands or the Isle of Man

11. In paragraph 61 of the Scheme, the words "the Isle of Man or in the Republic of Ireland" shall be deleted and the words "or in the Isle of Man" inserted in their place.

Registered postal packets to and from the Channel Islands or the Isle of Man

- 12.—(1) In paragraph 64 of the Scheme, the words "the Isle of Man or the Republic of Ireland" shall be deleted in all places where they occur, and the words "or the Isle of Man" inserted in their place, and the words "or in that Republic" shall be deleted.
- (2) In sub-paragraph (2) of paragraph 64 of the Scheme, the words " (including a registered parcel posted as such in the Republic of Ireland)" shall be deleted.

No compensation for compulsorily registrable packets to and from the Channel Islands or the Isle of Man

13. In paragraph 65 of the Scheme, the words "the Isle of Man or the Republic of Ireland" shall be deleted and the words "or the Isle of Man" inserted in their place.

Parcels on which compensation fee paid

14. In sub-paragraph (a) of paragraph 66 of the Scheme, the words "the Isle of Man or the Republic of Ireland" shall be deleted and the words "or the Isle of Man" inserted in their place.

Compensation for certain postal packets to and from the Channel Islands and the Isle of Man

15. In paragraph 67 of the Scheme as subsequently amended, "£18" shall read "£20". The words "the Isle of Man or the Republic of Ireland" shall be deleted and the words "or the Isle of Man" inserted in their place. The words "or the Republic" shall be deleted in both places where they occur. The words "In the case of a Datapost packet posted for transmission between the British postal area and the Republic of Ireland, no compensation shall be payable" shall be deleted.

Postage not prepaid or insufficiently prepaid

"8. Articles for loss of, or damage to, which no compensation may be paid:

- (a) any uncrossed postal order in which the name of the payee has not been inserted;
- (b) any cheque or dividend warrant which is uncrossed and payable to bearer;
- (c) any bearer security (including a share warrant, scrip or subscription certificate, bond or relative coupon);
- (d) any bank note or currency note, being current in the British postal area or elsewhere;
- (e) any unobliterated postage or revenue stamp valid for current use in the British postal area or elsewhere (except a revenue stamp embossed or impressed on an instrument which has been executed);
- (f) any National Insurance or Savings stamp;
- (g) any coupon, voucher, token, card, stamp or similar document, exchangeable (singly or with any other such document) for money, goods or services;
- (h) coin;
- (i) jewellery."
