Interpretation

3. In sub-paragraph (1) of paragraph 7 of the Scheme, the words: "not being an "area rate parcel", or being an area rate parcel not redirected to an address within the prescribed area for that parcel" shall be deleted.

The Coast Protection (Notices) Regulations 1950

Notice is hereby given that the Ceredigion District Council acting in their capacity as Coast Protection Authority hereby give notice under sub-section 1 of section 5 of the above Act that they propose to carry out Coast Protection Work as described herein at Pen yr Ergyd Peninsula, Gwbert, Cardigan, in the county of Dyfed.

The work will consist of controlling the beach levels by means of a series of rock groynes over the frontage of Patch Caravan Park, combined with the transfer of a substantial quantity of shingle from the end of the existing spit for even distribution over the groyned frontage against the face of the dunes.

BARNET LONDON BOROUGH COUNCIL

The Barnet (Restriction of Waiting on Bus Stops) (No.) Traffic Order 198
