POST OFFICE SCHEME 3/1986

NOTE: The Scheme which follows this Note is made under Section 28 of the Post Office Act 1969 and amends the Post Office Overseas Parcel Post Scheme 1982. The Scheme, which comes into operation on 1st September 1986, revises HM Forces surface parcel postage rates and the maximum level of compensation for insured parcels sent through a British Forces Post Office or to a ship of the Royal Navy.

(This Note is not part of the Scheme.)

THE POST OFFICE OVERSEAS PARCEL POST AMENDMENT (NO. 6) SCHEME 1986

Made - - - - - 18th August 1986
Coming into operation - - - - - 1st September 1986

The Post Office, by virtue of the powers conferred upon it by Section 28 of the Post Office Act 1969 and of all other powers enabling it in this behalf, hereby makes the following Scheme:

Commencement and citation

1.—(1) This Scheme shall come into operation on 1st September 1986 and may be cited as the Post Office Overseas Parcel Post Amendment (No. 6) Scheme 1986.

(2) This Scheme shall be read as one with the Post Office Overseas Parcel Post Scheme 1982 (Post Office Scheme P3/1982) (hereinafter called "the Scheme") as amended by the Post Office Overseas Parcel Post Amendment (No. 1) Scheme 1983 (Post Office Scheme P2/1983), the Post Office Overseas Parcel Post Amendment (No. 2) Scheme 1984 (Post Office Scheme 4/1984), the Post Office Overseas Parcel Post Amendment (No. 3) Scheme 1985 (Post Office Scheme 3/1985), the Post Office Overseas Parcel Post Amendment (No. 4) Scheme 1985 (Post Office Scheme 5/1985) and the Post Office Overseas Parcel Post Amendment (No. 5) Scheme 1986 (Post Office Scheme 1/1986).

Insured parcels and uninsured parcels containing valuables

2. In sub-paragraph (1)(e) of paragraph 23 of the Scheme as subsequently amended, the amount "£100" shall be deleted and "£140" inserted in its place.

Rates of postage on parcels

3. For Part 2 of Schedule 1 to the Scheme, as substituted by the Post Office Overseas Parcel Post Amendment (No. 3) Scheme 1985, there shall be substituted the following:

Cash on delivery

2.—(1) In sub-paragraph (1) of paragraph 48 of the Scheme as subsequently amended, after the figure "65p" there shall be inserted the words "or, in the case of a parcel, £1.00".

(2) In sub-paragraph (6) of paragraph 48 of the Scheme as subsequently amended, after the figure "65p" and before the words "in respect of each packet" there shall be inserted the words "or, in the case of a parcel, 75p".

Parcel rates

3. Column 2 of item 4(a) of Schedule 1 to the Scheme shall be deleted and the following shall be substituted:

"Weight not exceeding 1 kg	£1.50
Exceeding 1 kg, but not exceeding 2 kg	£1.90
Exceeding 2 kg, but not exceeding 3 kg	£2.35
Exceeding 3 kg, but not exceeding 4 kg	£2.55
Exceeding 4 kg, but not exceeding 5 kg	£2.75
Exceeding 5 kg, but not exceeding 6 kg	£2.95
Exceeding 6 kg, but not exceeding 7 kg	£3.10
Exceeding 7 kg, but not exceeding 8 kg	£3.25
Exceeding 8 kg, but not exceeding 9 kg	£3.45
Exceeding 9 kg, but not exceeding 10 kg	£3.60 "

4. In column 2 of item 6 of Schedule 1 to the Scheme as subsequently amended, the figure "8p" shall be deleted and the figure "10p" inserted in its place.
