## POST OFFICE SCHEME 5/1986

Note: The Scheme which follows this Note is made under Section 28 of the Post Office Act 1969 and amends the Post Office Overseas Letter Post Scheme 1982. The Scheme, which comes into operation on 20th October 1986, revises certain postal charges, implements a differential postal charge for letters weighing not more than 20 grams and postcards for transmission to certain European destinations, and revises postal charges and the weight step structure for letters for transmission to H.M. Forces.

THE POST OFFICE OVERSEAS LETTER POST AMENDMENT (NO. 6) SCHEME 1986
Made .....................................15th September 1986
Coming into operation....................20th October 1986
The Post Office, by virtue of the powers conferred upon it by Section 28 of the Post Office Act 1969 and of all other powers enabling it in this behalf, hereby makes the following Scheme:

## Commencement and citation

1.-(1) This Scheme shall come into operation on 20th October 1986 and may be cited as the Post Office Overseas Letter Post Amendment (No. 6) Scheme 1986.
(2) This Scheme shall be read as one with the Post Office Overseas Letter Post Scheme 1982 (Post Office Scheme P2/1982) (hereinafter called "the Scheme") as amended by the Post Office Overseas Letter Post Amendment (No. 1) Scheme 1982 (Post Office Scheme P6/1982), the Post Office Overseas Letter Post Amendment (No. 2) Scheme 1983 (Post Office Scheme P4/1983), the Post Office Overseas Letter Post Amendment (No. 3) Scheme 1984 (Post Office Scheme 3/1984), the Post Office Overseas Letter Post Amendment (No. 4) Scheme 1985 (Post Office Scheme 4/1985) and the Post Office Overseas Letter Post Amendment (No. 5) Scheme 1986 (Post Office Scheme 2/1986).

## Interpretation

2. In sub-paragraph (1) of paragraph 3 of the Scheme as subsequently amended, the following definition shall be inserted following " Datapost packet":-
"European Economic Community destinations" means those countries or places specified in Schedule 4A.

## Letters and postcards other than airmail packets

3. Paragraph 5 of the Scheme shall be deleted and the following shall be substituted:
" 5.-(1) Postage at the rates specified in Part 1 of Schedule 1 shall be charged and paid on letters and postcards posted in the British postal area, or posted on board a ship registered in any part of the British postal area while the ship is on the high seas:
(i) for transmission to a person on board a ship of the Royal Navy (whether on the high seas or in any port or place outside the British postal area); or
(ii) for transmission to a member of the armed forces of the United Kingdom or of any other Commonwealth country serving outside the British postal area with the armed forces of the United Kingdom or of any other Commonwealth country, being transmission through a British Forces Post Office or a civilian Postal Administration in any Commonwealth or foreign country which has agreed to deliver without surcharge letters and postcards at the said rates.
(2) Postage at the rates specified in Part 2 of Schedule 1 shall be charged and paid on all outgoing letters and postcards for transmission to European Economic Community destinations.
(3) Postage at the rates specified in Part 3 of Schedule 1 shall be charged and paid on all other outgoing letters and postcards and on all other letters and postcards posted on board a ship registered in any part of the British postal area while the ship is on the high seas, for transmission to a person anywhere in the world.
(4) This paragraph does not apply to air mail packets."

## Bulk posting in mail bags

4.-(1) In sub-paragraph (1)(a) of paragraph 10 of the Scheme as subsequently amended, the amount " $£ 1.15$ " shall be deleted and " $£ 1.25$ " inserted in its place.
(2) In sub-paragraph (1)(b) of paragraph 10 of the Scheme as subsequently amended, the amount " $£ 1.35$ " shall be deleted and " $£ 1.40$ " inserted in its place.

## Registration

5. In sub-paragraph (2)(c) of paragraph 32 of the Scheme as subsequently amended, the amount " $£ 1.10$ " shall be deleted and " $£ 1.20$ " inserted in its place.

## Compensation for registered packets

6. In sub-paragraph (2)(a) of paragraph 33 of the Scheme as subsequently amended, the amount " $£ 600$ " shall be deleted and " $£ 650$ " inserted in its place.

## Advice of delivery, enquiries and claims for compensation

7. In sub-paragraph (1) of paragraph 38 of the Scheme as subsequently amended, the amount " 20 p " shall be deleted and " 21 p " inserted in its place.

## Infectious Perishable Biological Substances service

8. In sub-paragraph (3) of paragraph 50 of the Scheme, the amount " $£ 3$ " shall be deleted and " $£ 3.50$ " inserted in its place.

The Post Office, by virtue of the powers conferred upon it by Section 28 of the Post Office Act 1969, and all other powers enabling it in this behalf, hereby makes the following Scheme:

## Commencement and citation

1.-(1) This Scheme shall come into operation on 20th October 1986 and may be cited as the Post Office Inland Post Amendment (No. 18) Scheme 1986.

## Interpretation

## Application

3.-(1) In sub-paragraphs (a) and (c) of paragraph 4 of the Scheme, the words "the Isle of Man or in the Republic of Ireland" shall be deleted and the words "or in the Isle of Man" inserted in their place.
(2) In sub-paragraph (2) of paragraph 4 of the Scheme, the words "Isle of Man or the Republic of Ireland " shall be deleted and the words " or the Isle of Man " inserted in their place.

## Express delivery

4. In sub-paragraph (6) of paragraph 28 of the Scheme, the words "the Isle of Man or the Republic of Ireland " shall be deleted and the words " or the Isle of Man" inserted in their place.
