The Scheme, which comes into operation on the 3rd September 1990 revises references to the Post Office Inland Post Scheme 1979 (now replaced by Schemes of 1989) and references to letters, postcards and newspapers posted to European destinations.

### THE POST OFFICE OVERSEAS LETTER POST AMENDMENT (No. 10) SCHEME 1990

Made ......16th August 1990 Coming into operation ......3rd September 1990

The Post Office, by virtue of the powers conferred upon it by Section 28 of the Post Office Act 1969 and of all other powers enabling it in this behalf, hereby makes the following Scheme.

Commencement and Citation

1.-(1) This Scheme shall come into operation on the 3rd September 1990 and may be cited as the Post Office Overseas Letter Post Amendment (No. 10) Scheme 1990.

(2) This Scheme shall be read as one with the Post Office Overseas Letter Post Scheme 1982 (Post Office Scheme P2/1982) (hereinaster called "the Scheme") as amended by the Post Office Overseas Letter Post Amendmend (No. 1) Scheme 1982 (Post Office Scheme P6/1982), the Post Office Overseas Letters Post Amendment (No. 2) Scheme 1983 (Post Office Scheme P4/1983), the Post Office Overseas Letter Post Amendment (No. 3) Scheme 1984 (Post Office Scheme 3/1984), the Post Office Overseas Letter Post Amendment (No. 4) Scheme 1985 (Post Office Scheme 4/1985), the Post Office Overseas Letter Post Amendment (No. 5) Scheme 1986 (Post Office Scheme 2/1986), the Post Office Overseas Letter Post Amendment (No. 6) Scheme 1986 (Post Office Scheme 5/1986), the Post Office Overseas Letter Post Amendment (No. 7) Scheme 1987 (Post Office Scheme 2/1987) the Post Office Overseas Letter Post Amendment (No. 8) Scheme 1988 (Post Office Scheme 3/1988) and the Post Office Overseas Letter Post Amendment (No. 9) Scheme 1989 (Post Office Scheme L2/1989).

Interpretation

2.—(1) In sub-paragraph (1) of paragraph 3 of the Scheme as subsequently amended, the definition "air mail packet" shall be deleted and the following shall be substituted:

"air mail packet" means an outgoing postal packet for transmission to a destination outside Europe and intended by the sender to be conveyed through any part of its course in the post by an air mail service;".

- (2) In sub-paragraph (1) of paragraph 3 of the Scheme as subsequently amended, the words "All-up Newspaper" shall be deleted in both places where they occur and "European Airmail Newspaper" inserted in their place.
- (3) In sub-paragraph (1) of paragraph 3 of the Scheme as subsequently amended the following definitions shall be inserted following "Datapost Packet":

"European Airmail Letters and Postcards" means outgoing letters and postcards for transmission to any European destination and intended by the sender to be conveyed through any part of the post by the European Airmail Letter and Postcard Service, whether or not bearing any indication that it should be so conveyed, and references to any "European Airmail Letter" or "European Airmail Postcard" shall be construed accordingly.

Letters and postcards other than airmail packets.

3. Paragraph 5 of the Scheme as substituted by the Post Office Overseas Letter Post Amendment (No. 6) Scheme 1986 shall be deleted and the following shall be substituted.

"Letters and postcards other than airmail packets

- (1) Postage at the rates specified in Part 1 of Schedule 1 shall be charged and paid on letters and postcards posted in the British postal area, or posted on board a ship registered in any part of the British postal area while the ship is on the high seas:
  - (i) for transmission to a person on board a ship of the Royal Navy (whether in the high seas or in any port or place outside the British postal area); or
  - (ii) for transmission to a member of the armed forces of the United Kingdom or of any other Commonwealth country serving outside the British postal area with the armed forces of the United Kingdom or of any other Commonwealth country, being transmission through a British Forces Post Office or a civilian postal administration in any Commonwealth or foreign country which has agreed to deliver without surcharge letters and postcards at the said rates.
- (2) Postage at the rates specified in Part 2 of Schedule I shall be charged and paid on all European Airmail Letters and Postcards for transmission to European Economic Community destinations.
- (3) Postage at the rates specified in Part 3 of Schedule 1 shall be charged and paid on all other outgoing letters and postcards and on all other letters and postcards posted on board a ship registered in any part of the British postal area while the ship is on the high seas, for transmission to a person anywhere in the world.
  - (4) This paragraph does not apply to air mail packets.

Reduced rate printed packets

4. In sub-paragraph (2)(e) of paragraph 6 of the Scheme, the words "All-up Newspapers" shall be deleted and "European Airmail Newspapers" inserted in their place.

Other printed packets and small packets

5. In sub-paragraph (3) of paragraph 7 of the Scheme as subsequently amended, the words "All-up Newspapers" shall be deleted and "European Airmail Newspapers" inserted in their place.

Payment of postage and fees

6. In sub-paragraph (6) of paragraph 16 of the Scheme as subsequently amended, the words "Post Office Inland Post Scheme 1979" shall be deleted in both places where they occur and the words "Post Office Inland Letter Post Scheme 1989" inserted in their place.

Printed packets

7. In sub-paragraphs (7) and (8) of paragraph 22 of the Scheme, the words "All-up Newspaper" shall be deleted wherever they occur and the words "European Airmail Newspaper" inserted in their
